The QUEEN's Most Excellent Majesty in Council.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the eighth and ninth years of Her Majesty, chapter seventy; and of the Act of the nineteenth and twentieth years of Her Majesty, chapter fiftyfive; duly prepared and laid before Her Majesty in Council a representation, bearing date the third day of August, in the year one thousand eight hundred and sixty-five, in the words and figures following; that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the eighth and ninth years of your Majesty, chapter seventy; and of the Act of the nineteenth and twentieth years of your Majesty, chapter fifty-five; have prepared, and now humbly lay before your Majesty in Council, the following representation as to the assignment of a consolidated chapelry to the consecrated church of Saint Andrew, situate in the parish of Hillingdon, in the county of Middlesex and in the diocese of London.

"Whereas at certain extremities of the said parish of Hillingdon and of the parish of Cowley, in the county and diocese aforesaid, which lie contiguous one to another, and are described in the schedule hereunder written, there is collected together a population, which is situate at a from the several churches of such

respective parishes.

"And whereas it appears to us to be expedient that such contiguous portions of the said parish of Hillingdon, and of the said parish of Cowley, should be formed into a consolidated chapelry for all ecclesiastical purposes, and that the same should be assigned to the church of Saint Andrew aforesaid.

" Now, therefore, with the consents of the Right Honorable and Right Reverend Archibald Campbell, Bishop of the said diocese of London, as such bishop, and also as the patron in right of his see of the vicarage of the said parish of Hillingdon, and of William Edward Hilliard, of Cowleyhouse, in the said county of Middlesex, Esquire, the patron of the rectory of the said parish of Cowley (in testimony whereof they have respectively signed and sealed this representation), we humbly represent that it would, in our opinion,

T the Court at Windsor, the 9th day of be expedient that all those contiguous portions of September, 1865. said parish of Cowley, which are described in the schedule hereunder written, all which portions, together with the boundaries thereof, are delineated and set forth on the map or plan hereunto annexed, should be united and formed into one consolidated chapelry for the said church of Saint Andrew, situate in the parish of Hillingdon as aforesaid, and that the same should be named 'The Consolidated Chapelry of Saint Andrew, Hillingdon;' and that the right of presentation and appointment to the church of such consolidated chapelry should belong to and be exercised by the bishop for the time being of the said diocese of London.

"We, therefore, humbly pray, that your Majesty will be graciously pleased to take the premises into your Royal consideration, and to make such Order in respect thereto as to your Majesty, in

your Royal wisdom, shall seem meet.

The SCHEDULE to which the foregoing Representation has reference.

"The Consolidated Chapelry of Saint Andrew, Hillingdon, being:-

"All that portion of the parish of Hillingdon, in the county of Middlesex and in the diocese of London, and also all those several detached por-tions of the parish of Cowley, in the same county and diocese, which are comprised within an imaginary line, commencing at a point in the centre of Stafford-bridge, which carries the turnpike-road from Hillingdon to Uxbridge over the Ickenham-brook; and extending thence southwestward along the middle of the said brook for a distance of two hundred and twenty-three yards, or thereabouts, as far as a point on the boundary dividing the said parish of Hillingdonfrom a certain detached portion of the parish of Cowley aforesaid; and extending thence first north-westward then westward, and finally southward along the said boundary to a boundary stone inscribed 'H. St. A. C. C., 1865, and placed on the western side of the road leading from Greenway to Cowley Church, at a point in the middle of the eastern end of the fence dividing the close numbered 1294 upon the map of the inclosure award of the said parish of Hillingdon, and upon the map hereunto annexed, from the close numbered 1292 upon the same maps; and extending thence westward along the middle of the said fence to the boundary at the western extremity of such fence, which divides
