the purchaser desires, being within the limits of the jurisdiction of the local authority; the license to state the number and quality of the animals, and the time for which it is granted, and the public roads by which they are to travel; the license to be carried by the person who has the charge of the animals.

4. One Justice, within the division in which he resides, may, at his discretion, grant a license to move, on a day to be named therein, in the daytime only, any fat beast to a place to be specified, for slaughter, or to a railway station, upon a declaration (to be retained by the Justice) being made before him by the owner, or by some person authorised by the owner, that the said animal has been in his possession for at least one month last past, is healthy and free from Cattle Plague, and is intended to be slaughtered at the place named, within 48 hours from the day of removal, or is intended to be sent by railway out of the jurisdiction of the local authority (as the case may be); and the condition of the license shall be, that if the said animal be not slaughtered within the time specified, or be afterwards found alive in any place within the limits of the jurisdiction of the local authority, the person in whose possession it shall be so found shall be liable to the penalty under the Statute not exceeding £20.

5. That the police constables of the county be instructed to keep a strict look out upon all turnpike roads and highways within the jurisdiction of the local authority of the county of Warwick, and whenever they discover any such animal being upon or being driven along any public road, without any of the aforesaid licenses, to give information to some one of the Justices of the division, or their clerk. Every such license to be produced, on demand, to any police constable, or to any owner or occupier of land adjoining, on either side of the public road on which such

cattle shall be found.

6. Any wilful infraction of these orders, or any false declaration or misrepresentation made for the purpose of obtaining any of the foregoing licenses, or refusal to produce them when lawfully demanded, shall subject the offender to the penalty under the statute not exceeding £20, in addition to any other proceedings to which he may be legally liable.

7. It is recommended by the Court that no fee be demanded or taken upon any declaration or

lieense under these Orders.

8. Ordered, that these sessions be further adjourned to Saturday, the 3rd day of February, 1866, at two o'clock in the afternoon.

## CATTLE PLAGUE.

## Borough of Neath.

I, THE undersigned, John Henry Rowland, Esquire, Mayor of the said borough, by virtue of the powers vested in me as the local authority therein, do hereby and in pursuance of the several Orders of Her Majesty's Most Honourable Privy Council, dated respectively the 23rd day of November and the 16th day of December, both now last past, revoke all appointments made, notice. given, and other acts done by any local authority within the said borough, under and by virtue of any Order of the Lords of Her Majesty's Privy Council in this matter, and subject to the exceptions and conditions in the said Orders con-

tained, I do hereby, in further pursuance of the said Orders, declare that, with a view to prevent the spreading of the disorder generally designated the "Cattle Plague," it is expedient from and after this date to prevent the removal of any cow, heifer, bull, bullock, ox, calf, or any other horned animal, to any market or fair, or to any place whatever within the said borough, except under the conditions hereinafter mentioned; and also to prevent the removal of any such animal from any place in Great Britain into any place within the said borough, except under the conditions hereinafter mentioned.

The conditions hereinbefore referred to are:—
I.—That, subject as aforesaid, no such animal brought by water, railway, or otherwise, shall be landed within, or be allowed to enter the said borough, except for the purpose of being slaughtered, and not even then until after the Inspector of the district shall, in each case, have certified that the same is free from disease.

II.—That every such animal shall be slaughtered within forty-eight hours from the time when such Inspector shall have given his said certificate.

III.—That upon the receipt of such certificate, all such animals shall, on and after Wednesday next, be immediately taken to the public slaughter house within the said borough, prior and in order to their being so slaughtered as aforesaid, whither they shall continue to be taken until the said Inspector, by my authority, shall appoint any other place fit for their reception.

And I do hereby order that the said conditions shall be strictly observed accordingly.

Penalty.

Any person after this date offending against the said Orders, or against the above notice, declaration, conditions, and order, will, for every such offence, be liable to forfeit the sum of £20.

This notice and Order will be enforced until

the 1st day of March next.

I, THE Right Honourable William Chambers, Lord Provost of the city of Edinburgh, by virtue of the power and authority conferred on me, by the Order of the Lords of Her Majesty's Most Honourable Privy Council, of date the 23rd day of November, 1865, hereby declare, in terms of the 16th section of the said Order, that with a view to prevent the spreading of the disorder generally designated the "Cattle Plague," it is expedient from this date to the 1st day of March next, to prevent the removal of any cow, heifer, bull, bullock, ox, or calf to the Edinburgh Cattle Market, or to any place whatever within the city of Edinburgh, for the purpose of exhibition or sale, except under the condition that they shall be immediately after such exhibition or sale, slaughtered within my jurisdiction: and in terms of the 18th section of the said Order, I hereby declare that it is expedient, with a view to prevent the spreading of the said disorder, that from this date to the 1st day of March next, no animal of the descriptions above specified shall be
