NOTICE TO MARINERS.

(No. 3.)—MEDITERRANEAN.—ADRIATIC.

*Harbour Light at St. Cataldo.*

THE Minister of Marine at Florence has given notice, that on and after the 16th day of November, 1865, a light would be established at St. Cataldo, near Lecce, on the coast of Italy.

The light is a *fixed* white light, at an elevation of 56 feet above the mean level of the sea, and in clear weather should be seen from a distance of 6 or 7 miles.

The tower is square, and rises from a large house at about 120 yards from the sea, in lat. 40° 23' 25" N., long. 18° 19' East of Greenwich.

*Harbour Light at Port Camogli, Gulf of Genoa.*

Also, that on the 1st day of January, 1866, a *fixed red* light would be established on the south end of the mole at the port of Camogli. The light is 23 feet above the sea, and visible 3 miles.

WEST COAST OF ITALY.

*Revolving Light on Anzio or Anzo Point.*

The Minister of Commerce and Public Works at Rome has given notice, that on and after the 1st day of January, 1866, a light would be exhibited from a lighthouse recently erected on Anzio or Anzo point, on the coast of the Roman States.

The light is a *revolving* white light, attaining its greatest brilliancy every *minute*. It is elevated 92 feet above the mean level of the sea, and in clear weather should be seen at a distance of 15 miles.

The illuminating apparatus is dioptric or by lenses, of the third order.

The tower is round, built on a house, and 38 feet high, in the old battery called Gregoriana, which is at the extremity of the point west of the mole of the ancient port of Neron. Its position is given in lat. 41° 26' 45" N., long. 12° 37' 21" East of Greenwich, or about 4½' west of that of the Admiralty charts.

The harbour light is a *fixed red* light, placed on the wall at the point of the mole of port Innocent XII. It is 23 feet above the level of the sea, and visible 3 miles.
