swine, or any raw or untanned hides, skins, horns, or hoofs of any such animals, or the offal of any such animals, or any dung, hay, straw, fodder, or litter, likely to propagate infection, shall be removed or taken from any part or parts of the county of Carnarvon lying to the east of the River Conway into any other part or parts of the same county, for any purpose or under any conditions whatever, except as hereinafter provided.

And that until such further notice, no such animals as aforesaid, or any such hides, skins, horns, hoofs, offal, or other articles as aforesaid, shall be removed or taken to any market or fair within any part of the said county, for the purpose of exhibition or sale.

Ċ

And that no such animals, or any such hides, skins, horns, hoofs, offal, or other articles as aforesaid, shall be brought into the said county, or any part thereof, from any place or places whatsoever (except that cattle, sheep, and pigs for immediate slaughter, or hay, straw, and fodder may be brought by road only into the said county from any part of the county of Anglesey, except the parish of Holyhead).

Provided always that (with the exception of cattle as defined by Section 3 of the said Cattle Diseases Prevention Act, 1866), it shall not be unlawful for any person to send or carry sheep, goats, or swine, or any hides, skins, horns, hoots, offal, or other articles as aforesaid, by railway through the said county.

Provided also that it shall not be unlawful for any person to remove or take hay, straw, and fodder, by road only, and for the purpose of feeding only, but not for sale, from any part or parts of the county of Carnarvon lying to the east of the River Conway, into any other part or parts of the same county, with a license signed by two Justices of the same county, during a time to be specified in such license.

Provided also that it shall not be unlawful for any person to bring or send (with a license signed by two Justices of the same county), any such hides, skins, horns, hoofs, offal, or other articles as aforesaid, from any land or premises in his own occupation, beyond the jurisdiction of the said county, which shall be free from the cattle disease, to any other land or premises in his own occupation, within the jurisdiction of the said county, during a time to be specified in such

Every person offending against the above Order is liable to a penalty of not exceeding £20.

## CATTLE PLAGUE.

Notice.

Anglesey to wit.

At the General Quarter Sessions of the Peace of our Sovereign Lady the Queen, held at Beaumaris, in and for the said county of Anglesey, on Tuesday, the 2nd day of January, in the 29th year of the reign of our Sovereign Lady Victoria, by the grace of God of the United Kingdom of Great Britain and Ireland, Queen, Defender of the Faith, and in the year of our Lord, 1866, and from thence continued by several adjournments to and holden at Beaumaris aforesaid, in and for the said county, on Tuesday, the 27th day of February, 1866, before certain Justices of our

said Lady the Queen, assigned to keep the Peace in the said county, and so forth.

By virtue of an Act passed in the 11th and 12th years of Her present Majesty's reign, chap. 107, and continued by several subsequent Acts, and of certain Orders of the Lords of Her Majesty's Most Honourable Privy Council, dated respectively the 23rd day of November, 1865, the 16th day of December, 1865, the 20th day of January, 1866, the 6th day of February, 1866, and the 23rd day of February, 1866, and also of an Act passed in the 29th year of Her said Majesty's reign, chap. 2, the Justices of the Peace for the said county assembled in Quarter Sessions as aforesaid, do (as the local authority constituted under the said Order in Council of the 16th day of December, 1865, and the Act of Parliament last mentioned), declare that it is expedient to make the several Orders hereinafter contained, and do order accordingly :-

1. That from and after the 1st day of March next to the 1st day of June next, it shall not be lawful for any person to bring any cow, heifer. bull, bullock, ox, calf, sheep, lamb, goat, or swine, nor any raw or untanned hides or skins, nor any horns or hoofs or other parts of any animals as defined as aforesaid (except as in the said Order in Council of the 20th day of January last is excepted), nor any offal of any such animals as aforesaid, nor any dung, hay, straw, fodder, or litter, whether adhering to any carriage or brought in any crate, hamper, parcel, or otherwise, and likely to propagate infection, from any place in the county of Carnarvon, or from any other place in Great Britain beyond the jurisdiction of this Court (except only from the borough of Beaumaris) into any place whatever within the jurisdiction of the same, nor to convey or send by railway from any place within the said jurisdiction to any other place within the same, any offal of any animal as above mentioned, nor any dung, hay, straw, fodder, or litter, whether adhering to any carriage or otherwise, and likely to propagate infection.

2. That it shall not be lawful for any person to bring or send into, or expose for sale, at any of the markets or fairs, or any other place within the said jurisdiction, except upon his own premises, any animal of the description above mentioned

(except sheep and swine).

3. That the Justices of the Peace acting in and for the First Petty Sessional Division of the said county be, and they are hereby appointed a committee of the local authority for the said First Division. And that the Justices of the Peace acting in and for the Second Petty Sessional Division of the said county be, and they are hereby also appointed a committee of the local authority for such Second Division. Such committees respectively to have power to appoint a certain number of other persons being ratepayers within their respective divisions to form part of such committee.

4. That all the powers conferred by the said Act of the 29th Vict., chap. 2, upon the local authority, be delegated to the said respective committees, excepting the power to make a rate.

-5. That each committee shall have the power to appoint two additional Inspectors for the respective divisions when the necessity for such appointment shall arise.

And notice is hereby given, that every person offending against the above-named Orders is liable to a penalty of not exceeding £20.
