The Queen has been pleased to grant unto Sir Frederick William Adolphus Bruce, commonly called the Honourable Sir Frederick William Adolphus Bruce, Knight Grand Cross of the Most Honourable Order of the Bath, and Her Majesty's Envoy Extraordinary and Minister Plenipotentiary to the United States of America, Her Royal licence and authority that he and his issue may, in compliance with a proviso contained in the last will and testament of the Right Honourable Lady Frances Elizabeth Wright-Wilson, late of Chelsea Park, in the county of Middlesex, and of Drayton Lodge, in the county of Southampton, the widow and relict of Sir Henry Wright-Wilson, late of Chelsea Park aforesaid, and of Crofton Hall, in the county of York, Knight, both deceased, take and henceforth use the surname of Wright in addition to and before that of Bruce, and that he and they may bear the arms of Wright quarterly in the second quarter with those of Bruce; such arms being first duly exemplified according to the laws of arms, and recorded in the College of Arms, otherwise the said Royal licence and permission to be void and of none effect:

And to command that the said Royal concession and declaration be registered in Her Majesty's said College of Arms.

THE Right Honourable the Lords of the Committee of Privy Council for Trade have received, from the Secretary of State for Foreign Affairs, an Extract from the "Moniteur," relative to the importation into France of Peruvian guano and borax, of which the following is a translation:—

# ARTICLE I.

An Arrangement relative to the importation of Peruvian guano into France and the French colonies having been signed, December 2, 1866, between France and Peru, the aforesaid Arrangement, the substance of which follows, has been approved and will receive its full and entire execution:—

## ARRANGEMENT.

The Government of His Majesty the Emperor of the French and the Government of the Republic of Peru, wishing to facilitate, by new arrangements reciprocally advantageous to the two countries, the development of the consumption of Peruvian guano in France and in the French colonies, have agreed to substitute the following
