

**A**T the Court at *Buckingham Palace*, the 19th day of *March*, 1867.

PRESENT,

The QUEEN's Most Excellent Majesty in Council.

**W**HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the fifty-ninth year of His Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of Her Majesty, chapter forty-nine; and of the Act of the nineteenth and twentieth years of Her Majesty, chapter fifty-five, duly prepared and laid before Her Majesty in Council a representation, bearing date the twenty-eighth day of February, in the year one thousand eight hundred and sixty-seven, in the words and figures following; that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the fifty-ninth year of His Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of your Majesty, chapter forty-nine; and of the Act of the nineteenth and twentieth years of your Majesty, chapter fifty-five, have prepared, and now humbly lay before your Majesty in Council, the following representation as to the assignment of a district chapelry to the consecrated church of Saint Paul, situate within the limits of the chapelry of Saint Mary, Penzance, in the parish of Madron, in the county of Cornwall, and in the diocese of Exeter.

"Whereas it appears to us to be expedient that a district chapelry should be assigned to the said church of Saint Paul, situate within the limits of the chapelry of Saint Mary, Penzance, as aforesaid.

"Now, therefore, with the consent of the Right Reverend Henry, Bishop of the said diocese of Exeter (testified by his having signed and sealed this representation), we, the said Ecclesiastical Commissioners, humbly represent that it would, in our opinion, be expedient that all that part of the said chapelry of Saint Mary, Penzance, which is described in the schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned as a district chapelry to the said church of Saint Paul, situate within the limits of such chapelry as aforesaid, and that the same should be named 'The District Chapelry of Saint Paul, Penzance.'

"And, with the like consent of the said Henry, Bishop of the said diocese of Exeter (testified as aforesaid), we, the said Ecclesiastical Commissioners, further represent, that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, and churchings should be solemnized or performed at such church, and that the fees to be received in respect of the publication of such banns, and of the solemnization or performance of the said offices should be paid and belong to the minister of the same church for the time being: Provided always, that nothing herein contained shall be construed as expressing any intention on the part of us, the said Commissioners, to concur in or approve the taking of any fee for the performance of the office of baptism or for the registration thereof.

"We, therefore, humbly pray that your Majesty will be graciously pleased to take the premises into your Royal consideration, and to make such Order with respect thereto as to your Majesty, in your Royal wisdom, shall seem meet.

The SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of Saint Paul, Penzance, being:—

"All that part of the chapelry of Saint Mary, Penzance, in the parish of Madron, in the county of Cornwall, and in the diocese of Exeter, which is comprised within, and is bounded by an imaginary line, commencing upon the boundary which divides the said chapelry from the parish of Madron aforesaid, at a point in the middle of the road leading from Penzance to Madron, opposite to Treneere entrance gates; and extending thence first north-eastward and then south-eastward along the said boundary to its intersection by the footpath leading from Treneere to Penzance cattle market; and extending thence southward along the middle of the said footpath, passing in front of Prospect-place to the junction of such footpath with Tarrover-road; and extending thence eastward along the middle of the last-named road for a distance of twenty-seven yards, or thereabouts, to a point opposite to the middle of the northern end of the fence which divides the close numbered 843 upon the title commutation map of the said chapelry of Saint Mary, Penzance, and upon the map hereunto annexed, from the close numbered 842 upon the same maps; and extending thence south-eastward to and along the middle of such fences, and along the middle of the fences which stretch along the rear of and form the eastern boundary of the houses and premises situate on the eastern side of the road called Causeway-head (for a distance of one hundred and sixty yards, or thereabouts), to the eastern end of the wall or fence which forms the southern boundary of the building and premises known as the Quakers' Meeting House; and extending thence westward along the middle of the said wall or fence to its extremity on the eastern side of the said road called Causeway-head; and continuing thence, still westward, to a point in the middle of the same road; and extending thence, southward, along the middle of the said road, for a distance of twenty-seven yards, or thereabouts, to a point opposite to the eastern end of the wall or fence which divides the close numbered 888 upon the said maps from the house numbered 2017 upon the said map hereunto annexed, and situate on the western side of the road called Causeway-head, as aforesaid; and extending thence, westward, in a direct line, for a distance of fifty-five yards, or thereabouts, crossing the said close numbered 888, as aforesaid, to a point in the middle of the Back-lane which leads from the Cattle Market aforesaid, past the eastern end of Saint Paul's Church, into Clarence-street, and which is numbered 955 upon the maps aforesaid; and extending thence, first southward, and then westward, along the middle of the said Back-lane, to its junction with the said Clarence-street; and extending thence, first northward, and then north-eastward, along the middle of the same street, to its junction, near the southern corner of the Cattle Market before mentioned, with Saint Clare-street; and extending thence, north-westward, along the middle of the last-named street, for a distance of fifty-two yards, or thereabouts, to a point opposite to the middle of the south-eastern end of a certain other Back-lane which leads to Windsor-terrace, and is numbered 1004 upon the said maps; and extending thence, north-westward, to and along the middle of the last-mentioned Back-lane, to its junction with the road which faces Windsor-terrace aforesaid, and is numbered 1038 upon the
