said maps; and extending thence, south-westward, along the middle of the last-described road, to its junction with a certain occupation-road leading to the close numbered 35 upon the said maps; and extending thence, northward, along the middle of the last-described road, to a point in the middle of the eastern end of the fence which divides the close numbered 35, as aforesaid, from the closes numbered respectively 33 and 34 upon the same mans; and extending thence, north-westward, along the middle of the said fence, and along the middle of the fence dividing the close numbered 36 upon the said maps from the close numbered 31 upon the same maps, to the junction of the lastdescribed fence with the fence which divides the said close numbered 36 and the close numbered 38 upon the said maps from the plantation situate on the eastern side of York House, and numbered 26b on the same maps; and extending thence, northeastward, along the middle of the last-described fence, to its extremity on the southern side of the road leading from Penzance to Madron, as aforesaid; and extending thence, northward, and in a straight line, to the first-described point in the middle of the said road opposite to Treneere entrance-gates, where the said imaginary line commenced."

And whereas the said representation has been approved by Her Majesty in Council; now, therefore, Her Majesty by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Exeter.

The QUEEN's Most Excellent Majesty in Council.

HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the fifty-ninth year of His Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of Her Majesty, chapter forty-nine; and of the Act of the nineteenth and twentieth years of Her Majesty, chapter fifty-five, duly prepared and laid before Her Majesty in Council a representation, bearing date the twenty-eighth day of February, in the year one thousand eight hundred and sixty-seven, in the words following; that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the fifty-ninth year of His Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of your Majesty, chapter forty-nine; and of the Act of the nine-teenth and twentieth years of your Majesty, chapter fifty-five, have prepared, and now humbly lay before your Majesty in Council, the following representation as to the assignment of a district chapelry to the consecrated church of Saint James the Greater, situate at Eastbury, in the parish of Lambourn, in the county of Berks, and in the diocese of Oxford.

"Whereas it appears to us to be expedient that

a district chapelry should be assigned to the said church of Saint James the Greater, situate at Eastbury aforesaid.

"Now, therefore, with the consent of the Right Reverend Samuel, Bishop of the said diocese of Oxford (testified by his having signed and sealed this representation), we, the said Ecclesiastical Commissioners, humbly represent that it would, in our opinion, be expedient that all that part of the said parish of Lambourn, which is described in the schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned as a district chapelry to the said church of Saint James the Greater, situate at Eastbury as aforesaid, and that the same should be named 'The District Chapelry of Saint James the Greater, Eastbury.'

"And, with the like consent of the said Samuel. Bishop of the said diocese of Oxford (testified as aforesaid), we, the said Ecclesiastical Commissioners, further represent that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings, and burials should be solemnized or performed at such church, and that the fees to be received in respect of the publication of such banus, and of the solemnization or performance of the said offices, should be paid and belong to the minister of the same church for the time being : Provided always, that nothing herein contained shall be construed as expressing any intention on the part of us the said Commissioners to concur in or approve the taking of any fee for the performance of the office of baptism, or for the

registration thereof.

"We, therefore, humbly pray that your Majesty will be graciously pleased to take the premises into your Royal consideration, and to make such Order with respect thereto as to your Majesty, in your Royal wisdom, shall seem meet.

The SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of Saint James the Greater, Eastbury, being:-

"All that part of the parish of Lambourn, in the county of Berks, and in the diocese of Oxford, wherein the present incumbent of such parish now possesses the exclusive cure of souls, which is situate to the east of an imaginary line commencing on the boundary which divides the said parish from the particular district of Saint Marv. Lambourn Woodlands, sometime part of the said parish of Lambourn, at a point in the centre of the four cross roads at Great Cleeve-hill; and extending thence north-eastward along the middle of the road leading past Thornhill Copse to Bockhampton to the junction of such road with the road leading from Eastbury to Lambourn; and extending thence north-westward along the middle of the last-described road for a distance of fourteen chains, or thereabouts, to a point opposite to the middle of the south-western end of the road called Long Hedge, which leads past Sheepdrove; and extending thence, first north-eastward, and then north-westward, along the middle of the last-described road to its junction at Hyde Barn with the road leading over Hyde Down and Stancombe Down to Letcomb; and extending thence northeastward along the middle of the last-described road as far as the boundary which divides the said parish of Lambourn from the parish of Letcomb Basset, in the same county and diocese."
