

“East London Waterworks (Thames Supply) Act, 1867.”

An Act for authorising the East London Waterworks Company to make and maintain works in connexion with their present waterworks, and to raise further moneys, and to make arrangements with other parties and for other purposes, and of which the short title is “East London Waterworks (Powers) Act, 1867.”

An Act for conferring further powers on the Great Western Railway Company, in relation to their own undertaking and the undertakings of other Companies; and for other purposes.
