

PUBLIC HOUSE CLOSING ACTS, 1864 and 1865.

NOTICE OF ADOPTION OF ACTS BY LINTHWAITE, BARNSELY, AND NORTH BIERLEY, YORKSHIRE.

WHEREAS Meetings of the Local Boards for the districts of Linthwaite, Barnsley, and North Bierley, in the county of York, acting under the provisions of the Local Government Act, 1858, have adopted the Public House Closing Acts, 1864 and 1865, within those districts, and notice of such adoptions has been duly given in writing, to me, as one of Her Majesty's Principal Secretaries of State, as required by the said last hereinbefore recited Acts :

Now, therefore, I do hereby give notice, that such Acts have been duly adopted within the limits of the districts of the said Local Boards of Linthwaite, Barnsley, and North Bierley, respectively, and that, in accordance with the provisions of the said Public House Closing Acts, these Acts have the force of law within the said districts, from and after the expiration of one month from the date of the passing of the respective resolutions adopting the said Acts in such districts.

LOCAL GOVERNMENT ACT, 1858.

NOTICE OF ADOPTION OF ACT BY HUCKNALL TORKARD, BAMPTON, AND BARROW-IN-FURNESS.

WHEREAS the Local Government Act, 1858, has been adopted in the following places ; that is to say :—

Hucknall Torkard (Parish), Nottinghamshire ;
Bampton (District formed under Local Government Act, 1858), Devonshire ; and
Barrow-in-Furness (Borough), Lancashire ;

And whereas notices of such adoption by the aforesaid places have been duly given, and advertised as required by such Act ; and the period for appeal has now expired, and no such appeal has been made :

Now, therefore, I, as one of Her Majesty's Principal Secretaries of State, do hereby give notice, that the Local Government Act, 1858, has been duly adopted in the several hereinbefore-named places, and that, in accordance with the provisions thereof, the said Act has, at the expiration of two months from the date of the passing of the resolution of adoption in each of the several hereinbefore described instances, the force of law within such places. In the cases of Hucknall Torkard, and Bampton (they being places of less than 3000 each in population by the last census), I do, by reason of special circumstances, approve of the adoption of the said Act ; and do order that the Local Government Act, 1858, do come into force within the said places, at the expiration of two months from the respective dates of the adoption of such Act.
