- 5. All those Lairs being No. 71, Roman-road, Islington, in the occupation of William Newbury.
- 6. All those Lairs known as Laycock's Cattle Lairs, situate in the Liverpool-road, Islington, in the occupation of Ellen Nicholls.
- 7. All those Lairs known as Cross Keys Yard, situate in St. John-street, West Smithfield, Clerkenwell, in the occupation of John William Markham.
- 8. All those Lairs known as Collins's Lairs and situate in Goose-yard, St. John-streetroad, Clerkenwell, in the occupation of John Collins.
