LOCAL GOVERNMENT ACT, 1858.

ORDER SETTLING THE BOUNDARIES OF A DISTRICT OF HIPPERHOLME, IN THE WEST RIDING OF THE COUNTY OF YORK, FOR THE PURPOSES OF THE LOCAL GOVERNMENT ACT, 1858.

WHEREAS a Petition has been duly presented to me, as one of Her Majesty's Principal Secretaries of State, from ratepayers resident within the boundaries of a proposed district of Hipperholme, in the parish of Halifax, in the county of York, as set forth in such petition, praying me to settle and fix the boundaries of a district to be styled the "Hipperholme District," for the purposes of the Local Government Act, **1858.**

And whereas the said petition was duly signed, as required by the said Act, and set forth, likewise, the proposed boundaries of the district sought to be formed under its provisions, and shown in the plan accompanying such petition; and inquiry has now been duly made by Robert Morgan, Esquire, the Inspector appointed by me for such purpose, and he has reported to me thereon.

Now, therefore, I, as one of Her Majesty's Principal Secretaries of State as aforesaid, having taken the said petition and report into consideration, do hereby, in pursuance of the powers vested in me by the Local Government Act, 1858, make order as follows :—

1. That from and after the date of this present order, the boundaries hereinafter set forth and described and delineated on the plan hereinbefore referred to in and accompanying the Inspector's report, bearing date the 3rd day of August, 1868, shall form and constitute the boundaries of the district to be called the Hipperholme District, for the purposes of the Local Government Act, 1858, and that the parts included in such boundaries so described and delineated, shall, for the purposes of such Act, be deemed to be a place having a known and defined boundary, and may adopt the said Act accordingly. The aforesaid boundaries to commence at the point A on the aforesaid plan, at Bailiff Bridge, where the hamlets of Hipperholme and Clifton and the township of Wike meet, thence

northerly along the Wike Beck to the Leeds and White Hall turnpike-road, thence westerly along the north side of the said turnpike road, and including it, to B, where the said turnpike-road crosses Coley Beck, thence northerly along the said beck to C, on the boundary fence of the Priestly Green Farm, thence westerly along the said fence to D, at Brook-lane, thence along the north side of the said lane, and North Edge-lane, and including them to E, on the Brighouse and Denholme Gate Turnpike-road, thence northerly along the east side of the said turnpike-road, and including it, to F, at its junction with the road leading to Common Wood Delf, thence westerly along the north side of the said road, and including it, to the southerly end of Common Wood Cottages, thence westerly in a straight line across Common Wood Plantation to G, on the occupation road leading to Throstle Nest, thence northerly to H, on Jum Hole Beck, the boundary between the townships of Hipperholme-cum-Brighouse and Northowram, thence southerly along the said boundary to I, on the Red Beck, at the junction of the townships of Hipperholme-cum-Brighouse, Northowram, and Southowram, thence southerly along the said Red Beck to K, on the fence opposite Lower North Cliff Farm House, thence easterly to L, at Wood-lane, thence easterly across the said lane and Sutcliffe Wood to M, on the footpath leading from Wood Nook, thence south-easterly along the said footpath to N, on the Brighouse and Denholme Gate turnpike road, thence crossing the said turnpike road and along the footpath leading to Hill Top to O, at Spout House-lane, thence southerly along the west side of the said lane, and including it to P, thence south-easterly along the footpath to Jerry-lane, thence along the south side of the said Jerry-lane and Catherine Slack-lane, and including them to Q, where the latter meets South House-lane, thence northerly along the east side of the said South House-lane, and including it to Hoyle House Beck, thence easterly along the said Hoyle House Beck, and including it to R, on Clifton Beck, the boundary between the townships of Hipperholme-cum-Brighouse and Clifton, thence northerly along the said Beck to the starting point A, at Bailiff Bridge, thus completing the boundaries of the said Hipperholme district.

2. That Mark Dawson, Esq., of Hipperholme, Halifax, be Summoning Officer, and take forthwith all such steps as may be necessary under the hereinbefore recited Act, for convening a meeting of the ratepayers of the said district of Hipperholme, Halifax, to decide as to the adoption of the Local Government Act, 1858, within the boundaries of such Hipperholme district, as fixed and settled by this present Order.
