

WE, the Ecclesiastical Commissioners for England, having received a benefaction of eight hundred pounds sterling, in favour of the benefice of Blindley Heath, in the county of Surrey, and in the diocese of Winchester, in consideration whereof we have agreed to pay to the Incumbent of the same benefice, and to his successors, a yearly sum of twenty-six pounds thirteen shillings and four pence, do hereby, in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, grant to the Incumbent of the said benefice of Blindley Heath, and to his successors, to meet such benefaction, one other yearly sum or stipend of twenty-six pounds thirteen shillings and four pence, such yearly sum or stipend to be payable out of the common fund under our control, and to be calculated as from the day of the publication of these presents in the London Gazette, and to be receivable half-yearly, on the first day of May and on the first day of November in each and every year: Provided always, that if at any time lands, tithes, or other hereditaments sufficient to produce the yearly sum or stipend so payable out of our common fund as lastly herein mentioned, or any part thereof, shall be annexed by us to the said benefice, in substitution for such yearly sum or stipend, or for such part thereof, our liability for the payment of such yearly sum or stipend, or of such part thereof, as the case may be, shall thereupon and thereafter cease and determine.

WE, the Ecclesiastical Commissioners for England, in consideration of a benefaction consisting of one thousand and six hundred square yards, or thereabouts, of land, which have been permanently secured to the benefice of Hayfield, in the county of Derby, and in the diocese of Lichfield, do hereby, in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, sections five and eleven, grant and appropriate out of our common fund to the said benefice of Hayfield, to meet such benefaction, one capital sum of two hundred and forty-seven pounds sterling, to be applicable towards defraying the cost of providing a parsonage or house of residence for the said benefice, according to plans and a specification which have been approved by us, such capital sum, or the balance thereof unapplied to such purpose, to remain in the meantime in our hands, at interest after the rate of three pounds per centum per annum, and such interest to be paid to the Incumbent for the time being of the said benefice of Hayfield.

WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, sections five and eleven, do hereby grant to the Incumbent of the rectory of Fradswell, in the county of Stafford, and in the diocese of Lichfield, and to his successors Incumbents of the same rectory, one yearly sum or stipend of sixty-nine pounds, such yearly sum or stipend to be payable out of the common

fund under our control, and to be calculated as from the first day of May, in the year one thousand eight hundred and sixty-eight, and to be receivable half-yearly on the first day of May and on the first day of November in each and every year: and we do also hereby grant and appropriate out of our said common fund, to the said rectory of Fradswell, one capital sum of two hundred pounds sterling, to be applicable towards defraying the cost of enlarging and improving the parsonage or house of residence of the said rectory, according to plans and a specification to be approved by us, such capital sum, or the balance thereof unapplied to such purpose, to remain in the meantime in our hands, at interest after the rate of three pounds per centum per annum, and such interest to be paid to the Incumbent for the time being of the said rectory of Fradswell: Provided always, that if at any time lands, tithes, or other hereditaments sufficient to produce the said yearly sum or stipend of sixty-nine pounds, or any part thereof, shall be annexed by us to the said rectory, in substitution for such yearly sum or stipend, or for such part thereof, our liability for the payment of such yearly sum or stipend, or of such part thereof, as the case may be, shall thereupon and thereafter cease and determine.

WE, the Ecclesiastical Commissioners for England, in consideration of a benefaction consisting of one thousand two hundred and twenty-three square yards, or thereabouts, of land, which have been permanently secured to the benefice of Saint Matthew, Leicester, in the county of Leicester, and in the diocese of Peterborough, and of a further benefaction of seven hundred pounds sterling, which has been paid to us in favour of the same benefice, do hereby, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, sections five and eleven, grant to the Incumbent of the said benefice of Saint Matthew, Leicester, and to his successors Incumbents of the same benefice, one yearly sum or stipend of fifteen pounds and two shillings, such yearly sum or stipend to be payable out of the common fund under our control, and to be calculated as from
