Accrington Gas and Water.

Amendment of the existing Acts of the Company; Repeal of proviso to section 7 of "The Accrington Gas and Water Works Act, 1863," and power to the Company to supply the Township of Oswaldtwistle with Gas; Abandonment of Harwood Dean Reservoir, and North and South Catchwater Drains in connection therewith; Power to construct another Reservoir in Harwood Dean, with Catchwater Drains and Road in connection therewith; Confirmation of construction of the Cliff Reservoir Conduits and Road in connection therewith; Conduit from Henfield to Rishton; Extension of time for construction of reservoir adjoining Mitchell's House Reservoir; Power to acquire additional land near the Mitchell's House Reservoir; Revival of powers and grant of new powers for compulsory purchase of lands, &c.; Confirmation of acts and expenditure of the Company; Confirmation or alteration of agreement with James Lomax, Esquire, and power to enter into other agreements; Application of monies to purposes of proposed Act; Extension of the powers of the Company for recovery of rates and rents, and other powers.

NOTICE is hereby given, that application is intended to be made to Parliament in the ensuing Session by "The Accrington Gas and Water Works Company" (hereinafter called "the Company"), for an Act to effect the following or some of the following objects, amongst others:—

To amend, extend, and enlarge, or wholly or partially repeal "The Accrington Gas and Water Works Company's Act, 1854" and "The Accrington Gas and Water Works Act, 1863," (hereinafter referred to as the Acts of 1854 and 1863), and especially to repeal that part of the seventh section of the last-mentioned Act, which provides that nothing in that Act shall authorise the Company to supply gas or water within the township of Oswaldtwistle, in the parish of Whalley, in the county of Lancaster.

To authorise the Company to extend their limits for the supply of gas so as to include the township of Oswaldtwistle, in the parish of Whalley, in the county of Lancaster, and to authorise the Company to exercise within that township the powers for the supply of gas, and all the powers, authorities, and privileges, in relation to the supply of gas, and of meters, fittings, and other apparatus connected therewith or incident thereto respectively, which the Company can now exercise within the limits for the supply of gas defined by the Act of 1854 and the Act of 1863, or which they may, by the intended Act, be authorised to exercise within such limits, and to legalise and confirm all the acts and expenditure of the Company, in relation to the laying down of mains and pipes, and the supply of gas.
