and of meters, fittings, and other apparatus in that township prior to the passing of the intended

To enable the Company to relinquish and abandon the following works in the county of Lancaster, that is to say:—

A reservoir intended to be constructed upon certain farms belonging to James Lomax, Esquire, commonly called or known by the following names, viz:—Cotes, Whittles, Fearley Hey, Bradley Hall, Boston, Riley Hey, Upper Riley Hey, and Keb, and which reservoir was authorised by "The Accrington Gas and Water Works Act, 1863," and is described on the plans deposited with the Clerk of the Peace for the county of Lancaster in the month of November, 1862, in relation to the application to Parliament for that Act as "The Intended Harwood Dean Reservoir,"

A catchwater drain in connection with such last-mentioned reservoir, intended to commence upon Lower White Carr Farm, belonging to the said James Lomax, and to terminate in such last-mentioned reservoir, and which catchwater drain was authorized by the said Act of 1863, and is described on the said plans as "The North Catchwater Drain;"

A catchwater drain in connection with such last-mentioned reservoir, intended to commence at or near Cold Acre-lane, and to terminate in such last-mentioned reservoir, which catchwater drain was authorised by the said Act of 1863, and is described on the said plans as "The South Catchwater Drain;"

All which reservoirs and catchwater drains would, if constructed, be wholly situate in the township of Great Harwood, and in the parish of Blackburn.

To enable the Company to construct, complete, and maintain the following works in the county of Lancaster, that is to say:—

A reservoir or reservoirs with all necessary works, roads, and conveniences connected therewith, commencing at and upon a close of land commonly called or known as "Hen Moss Side," in the occupation of William Birtwistle, late belonging to James Lomax, Esq., but contracted to be purchased from him by the Company, and forming part of Riley Hey Farm, and terminating at and upon the Dean Brook, 190 yards or thereabouts to the north of the farm-house, commonly called or known as "Cotes Farm House," late belonging to the said James Lomax, but contracted to be purchased from him by the Company.

A catchwater drain conduit or line of pipes commencing at and in a close of land in the occupation of Richard Slater, at a point 290 yards or thereabouts, measuring in a north-easterly direction from the farm-house known as "Higher White Carr," in the occupation of Andrew Birtwistle, and terminating in the last-mentioned reservoir or reservoirs 120 yards or thereabouts, measuring in a southerly direction from the farm-house, commonly called Whittles, in the occupation of John Hartley.

A catchwater drain conduit or line of pipes commencing at and in a close of land called "Meadow," forming part of "Keb" Farm at a point 270 yards or thereabouts, measuring in a south-easterly direction from the said farm-house, known as "Cotes Farm House," and terminating in such last-mentioned reservoir or reservoirs 70 yards or thereabouts, measuring in a southerly direction from the said last-mentioned farm house.

A road in connection with the last-mentioned same city, Gentleman, the trustees acting under reservoir or reservoirs, and other works, com-the will of John Bowker, Esquire, late of Prestmencing at the southerly end of the proposed wich, in the said county, de eased, and of the

embankment of such reservoir or reservoirs, at or near a point 80 yards, or thereabouts, measuring in a southerly direction from the said farmhouse, called "Cotes Farm House," and terminating in Cold Acre-lane, at a point 280 yards, or thereabouts, measuring in a south-easterly direction from the farm-house, known as "Bradley Hall."

An aqueduct, conduit, or line of pipes already partially constructed (part whereof is or will be in tunnelling) commencing in and out of the reservoir hereinbefore lastly described, at a point 80 yards, or thereabouts, measuring in a north-westerly direction from the said farm-house, known as "Cotes Farm House," and terminating at the northerly corner of the reservoir next hereinafter described.

A reservoir already constructed by and belonging to the Company, and known as "The Cliff Reservoir," and situate in and upon four closes of land called Lower Hey, Little Hey, Slash, and Tom Meadow, forming part of the Lower Fold Farm, in the occupation of William Birtwistle.

A road in connection with the last-mentioned reservoir, and already partially constructed and other works commencing at the southerly end of the embankment of such reservoir, and terminating at a point 80 yards or thereabouts, measuring in a westerly direction from the farm-house known as Higher Fold, in the occupation of William Birtwistle.

An aqueduct, conduit, or line of pipes already partially constructed, commencing in and out of the last-mentioned reservoir, at the southerly side of such reservoir, and passing through the centre of the embankment of such reservoir, and terminating in the village of Lower Town, at a point where Queen-street forms a junction with Church-street.

An aqueduct, conduit, or line of pipes commencing at the northerly corner of the said reservoir called the Cliff Reservoir, and terminating at the point of junction of the public road leading from the village of Cliff to the village of Lower Town, with the public road leading from the said public road to the said farm-house known as Higher Fold.

All which reservoirs, catchwater drains, aqueducts, conduits, lines of pipes, and roads will be situate wholly within the township of Great Harwood, in the parish of Blackburn.

An aqueduct, conduit, or line of pipes commencing by a junction with the existing main pipe of the Company, in the village of Henfield, in the township of Clayton-le-Moors and parish of Whalley, at or near the Load of Mischief Inn, and terminating at or near the Roebuck Inn, in the village and township of Rishton, in the parish of Blackburn.

Which intended aqueduct, conduit, or line of pipes will be situate within the last-mentioned townships and parishes.

To extend the time for the construction by the Company of a reservoir, or the enlargement of a reservoir, with all necessary works and conveniences connected therewith respectively, authorised by "The Accrington Gas and WaterWorks Act, 1863," on the southerly side of and adjacent or near to, the existing reservoir of the Company in the township of Lower Booths, in the parish of Whalley, in the county of Lancaster, commonly called Mitchell's House Reservoir, in or near certain lands the property of John Moss Kirkman, now or late of Ardwick, in the city of Manchester, Surgeon, and George Lyon, of the same city, Gentleman, the trustees acting under the will of John Bowker, Esquire, late of Prestwich, in the said county, de eased, and of the
