(Purchase of Dukinfield Gasworks; Dissolution of Gas Company; Construction of new Gasworks; Supply of Gas by Local Boards; Levying of Rates; and Borrowing of Money.)

OTICE is hereby given, that application is intended to be made to Parliament in the ensuing session for leave to bring in a Bill to effect the following, or some of the following,

among other objects:

To vest in the Local Board of Health for the district of Dukinfield, and the Local Board of Health for the district of Denton (herein called "the Local Boards,") or one of them, or to authorise or provide for the vesting in them, or one of them, by purchase (upon such terms and conditions, and as from such period and in such proportions as have been or may be agreed upon, or as may be fixed by or under the provisions of the Bill), of the undertaking of the Dukinfield Gas Company (herein called "the Company"), and all the lands and works, property, real or personal, and effects, powers, rights and privileges, duties and liabilities of the Company, and to enable "the local boards," jointly and severally, or one of them, to exercise and enjoy within the limits of

needful powers, rights, and privileges for the supply of gas within those limits.

To enable "the local boards," jointly and severally, or one of them, to maintain, and from time to time to alter and enlarge all existing works of the Company now used for the manufacture or supply of gas.
