England, in pursuance of the Act of the sixteenth and seventeenth years of your Majesty, chapter fifty, and of the Act of the twenty-third and twenty-fourth years of your Majesty, chapter one hundred and twenty-four, have prepared, and now humbly lay before your Majesty in Council, the following scheme for effecting an exchange of the patronage of the benefice (being a perpetual curacy or a vicarage) of Saint Bartholomew, Quorndon, situate in the county of Leicester, and in the diocese of Peterborough, and of the benefice (being a perpetual curacy or a vicarage) of Saint Peter, Mountsorrel, situate in the same county and diocese, for the patronage of the bene-fice (being a vicarage) of Fulbourn, All Saints, situate in the county of Cambridge, and in the diocese of Ely.
