The Right Honourable Sir William Bovill, Knt., Lord Chief Justice of Her Majesty's Court of Common Pleas, at Westminster, has appointed John Henry Belfrage, of No. 36, Bedford-row, in the county of Middlesex, Gentleman, to be one of the Perpetual Commissioners for taking the acknowledgments of deeds to be executed by married women, under the Act passed for the abolition of fines and recoveries, and for the substitution of more simple modes of assurance, in and for the county of Middlesex, also in and for the city of London, and the city and liberties of Westminster.

WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, do hereby grant to the Incumbent of the vicarage of Saint Peter, Birmingham, in the county of Warwick, and in the diocese of Worcester, and to his successors Incumbents of the same vicarage, one yearly sum or stipend of sixteen pounds, such yearly sum or stipend to be payable out of the common fund under our control, and to be calculated as from the first day of May, in the year one thousand eight hundred and sixty-eight, and to be receivable in equal half-yearly portions, on the first day of May and on the first day of November in each and every year: Provided always, that if at any time lands, tithes, or other hereditaments sufficient to produce the said yearly sum or stipend, or any part thereof, shall be annexed by us to the said vicarage, in substitution for such yearly sum or stipend, or for such part thereof, our liability for the payment of such yearly sum or stipend, or of such part thereof, as the case may be, shall thereupon and thereafter cease and determine.

In witness whereof, we have hereunto set our common seal, this fourth day of November, in the year one thousand eight hundred and sixty-nine.

WE, the Ecclesiastical Commissioners for England, in consideration of a benefaction of three thousand pounds sterling, which has been paid to us in favour of the district of All Saints, Woodlesford, in the county of York, and in the diocese of Ripon, and in respect of which we have agreed to pay to the Minister of the same district, and to his successors, a yearly sum of one hundred pounds, do hereby, in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, grant to the Minister of the said district of All Saints, Woodlesford, and to his successors, to meet such benefaction, one yearly sum or stipend of fifty pounds, such yearly sum or stipend to be payable out of the common fund under our control, and to be calculated as from the day of the pub-
