

LOCAL GOVERNMENT ACT, 1858.

KNARESBOROUGH.

WHEREAS the Local Board in and for the district of Knaresborough and Tentergate, in the county of York, has, with the consent of a meeting of ratepayers and owners of property within such district, held on the 24th day of February last, the said consent being expressed by resolution, as required by the 50th section of the Local Government Act, 1858, obtained power to do, for the establishment of a Market in the said district, the things provided under the first subdivision of the said section, of which notice has been duly given to me.
