In order to carry out the existing regulation that no presentation can be made at a Levee excepting by a person actually attending that Levee, it is also necessary that an intimation from the Nobleman or Gentleman who is to make the presentation, of his intention to be made at a Drawing Room excepting by a

present, should accompany the presentation card above referred to, which will be submitted to The Queen for Her Majesty's approbation. It is Her Majesty's command that no presentations shall be made at these Levees, except in accordance with the above regulations.

THE Right Honourable the Lords of the Committee of Privy Council for Trade have received from the Secretary of State for Foreign Affairs a copy of a Despatch from Her Majesty's Minister in Japan, enclosing the subjoined Notification, respecting the supply of coals to vessels in Japanese ports, which he has issued for the information of Her Majesty's subjects:—

NOTIFICATION.

The undersigned hereby makes known, for the general information of Her Britannic Majesty's subjects, that by an arrangement concluded between the Representatives of the Treaty Powers and the Japanese Government, all native coal exported in foreign steamers shall be held to be shipped for ship's use, and shall therefore be passed by the Custom-house free of duty; while all native coal exported in foreign sailing vessels shall pay the export duty of the Tariff attached to the Convention of Yedo, 1866.
