opposite to the middle of the south-western end of the street or road called or known as Kingsdown Parade: and extending thence, north-eastward to and along the middle of the said street or road, to its junction with the street or road called or known as Marlborough Hill; and extending thence, south-eastward for a distance of fifty yards or thereabouts along the middle of the last-named street or road to a point opposite to a boundary stone inscribed 'K. St. M. C. C., 1870, No. 1,' and placed on the north-eastern side of the same street or road, in the middle of the south-western end of the wall forming the north-western boundary of the house and premises called or known as Marlborough House; and extending thence, north-eastward to such boundary stone, and along the middle of the said wall to the south-western end of the road leading past the rear of the houses situate on the southern side of Kingsdown Parade aforesaid, towards Somerset-street; and continuing thence, north-eastward along the middle of the same road, and (crossing Montague Hill) along the middle of Somerset-street aforesaid as far as the point where the last-named street is intersected by the boundary dividing the said parish or parochial chapelry of Saint James, Bristol, from the new parish of Saint Andrew, Montpelier aforesaid; and extending thence, south-eastward along the last-described boundary, following thereby the middle of Hillgrove-street to the junction of such boundary with the boundary on the western side of the street or road called or known as Stokes Croft, which divides the said new parish of Saint Andrew, Montpelier, from the particular district of Saint Barnabas, Bristol, in the diocese of Gloucester and Bristol aforesaid; and extending thence, northward, along the last-described boundary, following thereby the western side of the lastnamed street or road, to its junction with Thomasstreet; and extending thence, north-westward along the south-western side of the last-named street to Fremantle-square; and continuing thence in the same direction along the south-western side of the road which passes along the south-western side of the said square, to a point at the western angle of the same square in the middle of the south-eastern extremity of the wall which divides the house and premises known as Maesteg Villa from the house and premises known as Dorset Villa, and continuing thence, still north-westward, along the middle of the last-described wall, and along the middle of the wall dividing the house and premises known as Creighton Villa, Nugent-bill, from the house and premises known as Clarendon Villa, Nugent-bill; and continuing in the same direction and in a straight line across the roadway of Nugent-hill, and along the south-western side of Spring Villa, to the wall which divides the house and premises known as No. 4, Clare-villas, from the house and premises known as No. 5, Clarevillas; and continuing in the same direction along the last-described wall, and across Clare-road, and following the wall dividing the house and premises known as No. 12, Clare-villas, from the house and premises known as No. 13, Clare-villas, to its north-western end; and continuing thence, still north-westward and in a straight line, in rear of the houses situate on the north-eastern side of the road called Nugent-place, to and along the middle of the wall dividing the house and premises known as No. 4, Fremantle-villas, Cotham-hill, from the house and premises known as No. 5, Fremantlevillas, Cotham-hill, to a boundary stone inscribed K. St. M. C. C., 1870, No. 2,' and placed upon the south-eastern side of the road called or known as Cotham-hill aforesaid, upon the boundary dividing the said new parish of Saint Andrew,

Montpelier, from the parish or parochial chapelry of Westbury-upon-Trym aforesaid; and extending thence north-eastward along the last-described boundary, following thereby the south-eastern side of the road called or known as Cotham-hill aforesaid, for a distance of two hundred and sixtysix yards, or thereabouts, to the intersection of the same boundary by Lower Redland-road; and extending thence north-westward for a distance of one hundred and sixty-four yards, or thereabouts, along the middle of the last-named road, to a point opposite to a boundary stone inscribed 'K. St. M. C. C., 1870, No. 3,' and placed on the western side of the same road, at the north-eastern end of the fence which divides the close numbered 340 upon the tithe commutation map of the said parish or parochial chapelry of Westbury-upon-Trym, and upon the map hereunto annexed, from the closes numbered respectively 338 and 337 upon the same maps; and extending thence southwestward to such boundary stone, and along the middle of the said fence, to a boundary stone inscribed 'K. St. M. C. C., 1870, No. 4,' and placed at the south-western end of the same fence, on the north-eastern side of a certain new road, intended to be called Cotham-grove; and continuing thence, still south-westward and in a direct line across the last described road to a point opposite to a boundary stone inscribed 'K. St. M. C. C., 1870, No. 5, and placed on the western side of the same road, at the north-eastern end of a certain other new road connecting Cotham-grove aforesaid with the road called or known as Cotham Park; and continuing thence, still south-westward, along the middle of the said new road (thereby passing the north-western end of Almaroad) to the junction of the same new road with the road called or known as Cotham Park aforesaid; and extending thence, south-eastward, for a distance of twenty-six yards or thereabouts, along the middle of the last named road to its junction with a certain cross road leading to Cotham Newroad; and extending thence, generally south-west-ward, along the middle of the said cross road to its junction with Cotham New-road aforesaid. opposite Sherwood Villa; and extending thence, westward, for a distance of one hundred yards or thereabouts, along the middle of the last-named road to its junction with Oxford-street; and extending thence, south-eastward, along the middle of the last-named street, to its junction with the street or road called or known as Clarence-place; and extending thence, westward, for a distance of one hundred and thirteen yards, or thereabouts, along the middle of the last-named street or road, to its intersection by the boundary which divides the said parish or parochial chapelry of Westburyupon-Trym from the parish of Saint Michael, Bristol aforesaid; and extending thence, generally south-eastward, along the last described boundary to its junction on the north-western side of Horfield-road aforesaid with the boundary which divides the said parish or parochial chapelry of Westbury-upon-Trym from the parish or parochial chapelry of Saint James, Bristol aforesaid, where the said imaginary line commenced."

And whereas the said representation has been approved by Her Majesty in Council, now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Acts; and Her Majesty, by and with the like advice, is
