The QUEEN's Most Excellent Majesty in Council.

W HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the eighth and ninth years of Her Majesty, chapter seventy; of the Act of the fourteenth and fifteenth years of Her Majesty, chapter ninety-seven; and of the Act of the nineteenth and twentieth years of Her Majesty, chapter fiftyfive, duly prepared and laid before Her Majesty in Council a representation, bearing date the sixteenth day of June, in the year one thousand eight hundred and seventy, in the words following; that is to say:

ing; that is to say: "We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the eighth and ninth years of your Majesty, chapter seventy; of the Act of the fourteenth and fifteenth years of your Majesty, chapter ninety-seven; and of the Act of the nineteenth and twentieth years of your Majesty, chapter fifty-five, have prepared, and now humbly lay before your Majesty in Council, the following representation as to the assignment of a consolidated chapelry to the consecrated church of Saint John the Evangelist, situate at Ravenhead, in the parish of Saint Helen's, in the county of Lancaster, and in the diocese of Chester.

"Whereas at certain extremities of the said parish of Saint Helen's, and of the particular district of Saint Thomas, Eccleston, in the county and diocese aforesaid, which said extremities lie contiguous one to another, and are described in the schedule hereunder written, there is collected together a population which is situate at a distance from the several churches of such parish and particular district respectively.

"And whereas it appears to us to be expedient that such contiguous portions of the said parish of Saint Helen's, and of the said particular district of Saint Thomas, Eccleston, should be formed into a consolidated chapelry for all ecclesiastical purposes, and that the same should be assigned to the said church of Saint John the Evangelist, situate at Ravenhead, as aforesaid.

"Now therefore, with the consent of the Right Reverend William, Bishop of the said diocese of Chester, with the consent of Gilbert Greenall, of Walton Hall, Warrington, in the said county of Lancaster, Esquire; of Edward Greenall, of Grappenball, near Warrington aforesaid, Esquire; of John Ansdell, of Cowley House, Saint Helen's, Solicitor; of William Whitley, of Liverpool, in the said county of Lancaster, Barrister-at-Law; of William Radcliffe, of Liverpool aforesaid, Solicitor; of Arthur Sinclair, of Garston, near Liverpool aforesaid, Ironfounder; of James Cross, of Ditton House, Warrington, Engineer; of James Haddock, of Saint Helen's, Coal Proprietor; of David Gamble, of Windlehurst, Saint Helen's, Chemical Manufacturer; of John Hammill, of Denton's Green, Saint Helen's, Glass Manufacturer; and of William Pilkington, junior, of

Sutton Grange, Saint Helen's, Glass Manufacturer, the patrons of the vicarage of the said parish of Saint Helen's; and with the consent of the said Gilbert Greenall, of the said Edward Greenall, of James Creswell Pigot, of Southport, in the said county of Lancaster, Esquire; of the Reverend Thomas Greenall, the rector or incumbent of the rectory of the parish of Grappenhall, in the said diocese of Chester; and of the Reverend John Tayleur Pigot, the rector or incumbent of the rectory of the parish of Fremington, in the diocese of Exeter, the patrons of the perpetual curacy of the said particular district of Saint Thomas, Eccleston (in testimony whereof they, the said consenting parties, have respectively signed and sealed this representation), we, the said Ecclesiastical Commissioners for England, humbly represent that it would in our opinion be expedient that all those contiguous portions of the said parish of Saint Helen's, and of the said particular district of Saint Thomas, Eccleston, which are described in the schedule hereunder written, all which portions, together with the boundaries thereof, are delineated and set forth on the map or plan hereunto annexed, should be united and formed into one consolidated chapelry for the said church of Saint John the Evangelist, situate at Ravenhead, as aforesaid, and that the same should be named 'The Consolidated Chapelry of Saint John the Evangelist, Ravenhead, and that the right of presentation and appointment to the church of the same consolidated chapelry should belong to and be exercised by the Reverend Edward Carr, Doctor of Laws, the present vicar or incumbent of the vicarage of the said parish of Saint Helen's, and by his successors, vicars or incumbents of the same vicarage for ever.

"We therefore humbly pray that your Majesty will be graciously pleased to take the premises into your Royal consideration, and to make such Order in respect thereto as to your Majesty, in your Royal wisdom, shall seem meet.

## The SCHEDULE to which the foregoing Representation has reference.

"The Consolidated Chapelry of Saint John the Evangelist, Ravenhead, being :--

"All those contiguous portions of the parish of Saint Helen's, and of the particular district of Saint Thomas, Eccleston, both in the county of Lancaster, and in the diocese of Chester, which are comprised within and are bounded by an imaginary line commencing upon the boundary which divides the said parish of Saint Helen's from the new parish of the Holy. Trinity, Parr Mount, in the county and diocese aforesaid, at a point where Peasley Cross-lane is crossed by the line of the Saint Helen's branch of the London and North-Western Railway; and extending thence, north-westward, for a distance of eight chains or thereabouts along the middle of the said branch line of railway to a point in the centre of the bridge which carries the same branch line of railway over the Saint Helen's Canal; and extending thence, first south-westward and then north-westward, for a distance of forty-three chains or thereabouts along the middle of the said canal to a point in the centre of Tavern Bridge; and extending thence, northward, along the middle of the said bridge to the boundary on the northern bank of the same canal which divides the said parish of Saint Helen's from the particular district of Saint Thomas, Eccleston aforesaid ; and extending thence, north-westward, along the last-described boundary to a point in the centre of Kitt's Bridge which carries Liverpool-road over
