

Hardshaw Brook; and extending thence, westward, along the middle of the last-named road to its junction with Liverpool-street; and extending thence, southward, along the middle of the last-named street to its junction with Garden-street; and extending thence, westward, for a distance of one hundred and fifty yards or thereabouts along the middle of the last-named street to a point at the western extremity of the same street in the wall forming the eastern boundary of the buildings and premises of the Eccleston Ropery, otherwise called or known as Glover's Rope Walk; and extending thence, south-westward, for a distance of one hundred and forty-seven yards or thereabouts along the middle of the said wall or fence to the north-eastern side of the line of the Eccleston branch of the London and North-Western Railway; and continuing thence, still south-westward, and in a direct line, to a point in the middle of the said branch line of railway; and extending thence, north-westward, for a distance of ninety yards or thereabouts along the middle of the same branch line of railway to the point where it crosses the cart road leading from Pythian-street to the Ravenhead British Plate Glass Works; and extending thence, generally south-westward, for a distance of four hundred and ninety yards or thereabouts along the middle of the said cart road to a point at the north-eastern end of Ravenhead Pond, upon the boundary, which divides the said particular district of Saint Thomas, Eccleston, from the parish of Saint Helen's aforesaid; and extending thence, first south-westward and then westward, for a distance of twenty-one chains or thereabouts along the last described boundary, to a point in the middle of the road called or known as the Carriage Drive, which leads from the said Ravenhead British Plate Glass Works to Cropper's Hill; and extending thence north-eastward for a distance of twenty-two chains, or thereabouts, along the middle of the last-named road to a point at the junction, at Cropper's Hill aforesaid, of the same road with the Liverpool, Prescott, Ashton, and Warrington Trust Road, such point being upon the boundary which divides the said particular district of Saint Thomas, Eccleston, from the new parish of Christ Church, Eccleston, in the county and diocese aforesaid; and extending thence, first south-westward, then south-eastward, and then north-eastward, along the last-mentioned boundary to its junction, near to the northern end of Thatto Heath, with the boundary which divides the last-named new parish from the parish of Saint Helen's aforesaid; and extending thence, generally southward, along the last-mentioned boundary, thereby passing along the eastern side of Thatto Heath aforesaid to the junction of the same boundary near to the Sutton Brewery with the boundary dividing the last-named parish from the new parish of Saint Anne, Rainhill, in the county and diocese aforesaid; and extending thence, first eastward, then north-eastward, and then again eastward, along the last-mentioned boundary to its junction at Sutton Heath with the boundary dividing the said parish of Saint Helen's from the parish of Sutton, in the said county and diocese; and extending thence, generally north-eastward, along the last-mentioned boundary to its junction at Peasley Cross with the said boundary, which divides the parish of Saint Helen's from the new parish of the Holy Trinity, Parr Mount, as aforesaid; and extending thence, generally northward, along the last-mentioned boundary to the first-described point where Peasley Cross-lane is crossed by the line of the Saint Helen's Branch of the London and North-Western

Railway at which point the said imaginary line commenced."

And whereas the said representation has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Chester.

**W**HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the fifty-ninth year of His Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of Her Majesty, chapter forty-nine; and of the Act of the nineteenth and twentieth years of Her Majesty, chapter fifty-five, duly prepared and laid before Her Majesty in Council a representation, bearing date the seventh day of July, in the year one thousand eight hundred and seventy, in the words and figures following; that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the fifty-ninth year of His Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of your Majesty, chapter forty-nine; and of the Act of the nineteenth and twentieth years of your Majesty, chapter fifty-five, have prepared, and now humbly lay before your Majesty in Council, the following representation as to the assignment of a district chapelry to the consecrated church of Saint Bartholomew, situate at Ruswarp, in the parish or parochial chapelry of Whitby, in the county of York, and in the diocese of York:

"Whereas it appears to us to be expedient that a district chapelry should be assigned to the said church of Saint Bartholomew, situate at Ruswarp as aforesaid.

"Now, therefore, with the consent of the Right Honourable and Most Reverend William, Archbishop of York (testified by his having signed and sealed this representation), we, the said Ecclesiastical Commissioners, humbly represent, that it would, in our opinion, be expedient, that all that part of the said parish or parochial chapelry of Whitby, which is described in the schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned as a district chapelry to the said church of Saint Bartholomew, situate at Ruswarp as aforesaid, and that the same should be named 'The District Chapelry of Saint Bartholomew, Ruswarp.'

"And, with the like consent of the said William, Archbishop of York (testified as aforesaid), we, the said Ecclesiastical Commissioners, further represent, that it appears to us to be expedient that banns of matrimony should be
