HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the third and fourth years of Her Majesty, chapter one hundred and thirteen; of the Act of the sixth and seventh years of Her Majesty, chapter thirty-seven; and of the Act of the nineteenth and twentieth years of Her Majesty, chapter one hundred and four, duly prepared and laid before Her Majesty in Council a scheme, bearing date the nineteenth day of January, in the year one thousand eight hundred and seventy-one, in the words and figures following; that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the third and fourth years of your Majesty, chapter one hundred and thirteen; of the Act of the sixth and seventh years of your Majesty, chapter thirty-seven; and of the Act of the nineteenth and twentieth years of your Majesty, chapter one hundred and four, have prepared, and now humbly lay before your Majesty in Council, the following scheme for constituting a separate district for spiritual purposes out of the parish of Heston, in the county of Middlesex, and in the diocese of London.

"Whereas it has been made to appear to us that it would promote the interests of religion that the particular part of the said parish of Heston, which is hereinafter mentioned and described (such part not at present containing within its limits any consecrated church or chapel in use for the purposes of living worship), should be constituted a separate

district in manner hereinafter recommended and

proposed: And whereas by a certain deed, bearing date on or about the eleventh day of August, in the year one thousand eight hundred and seventy, made or expressed to be made under the authority of the "New Parishes Acts, 1843, 1844, and 1856," or some or one of them, and being under the hands and seals of the Reverend Edward Spooner, vicar of the vicarage of the said parish of Heston, and of the Right Honourable and Right Reverend John, Bishop of the said diocese of London, and being also under the common seal of us, the said Ecclesiastical Commissioners (which deed is intended to be enrolled in your Majesty's High Court of Chancery at Westminster), the said Edward Spooner did grant and confirm unto the incumbent of the district hereinafter recommended to be constituted, so soon as one shall have been appointed and licensed thereto in accordance with the provisions of the herein secondly-mentioned Act, and to his successors, the incumbents thereof for the time being: -Firstly, a certain piece or parcel of land, containing by admeasurement three acres and three roods, or thereabouts, situate in the parish of Heston aforesaid, as the same is described in the said deed, and delineated in the plan drawn on the margin of the same deed; and, secondly, one clear yearly rent-charge or sum of one hundred pounds, to be payable half-yearly, and to be chargeable upon certain glebe lands, tithes or tithe rents charge, and hereditaments belonging to the said vicarage of the parish of

"And whereas the said piece or parcel of land, and the said yearly rent-charge or sum of one hundred pounds, have been so granted and confirmed as aforesaid, upon the understanding that we should make and pay out of the common fund created by the firstly herein-mentioned Act, to the incumbent for the time being of the said district hereinafter recommended to be constituted when such incumbent shall have been appointed and licensed as before-mentioned, a grant of fifty pounds per annum.

"And whereas we have agreed and undertaken to make such grant of fifty pounds per annum as aforesaid, by an instrument to be executed by us under our common seal, in accordance with the provisions of the Act of the twenty-ninth and thirtieth years of your Majesty, chapter one hundred and eleven,

"And whereas the said piece or parcel of land, and the said yearly rent-charge or sum of one hundred pounds, have been so granted and confirmed as aforesaid, upon the further understanding and condition that we should recommend and propose to your Majesty in Council, that the whole right of patronage of the said district hereinafter recommended to be constituted, and of the nomination of the incumbent thereof, should be assigned to, and should be vested in, the bishop for the time being of the said diocese of London, as the nominee of the said Edward Spooner, and he, the said Edward Spooner, has, by an instrument under his hand, nominated to us, the Right Honourable and Right Reverend John, now Bishop of the said diocese of London, and his successors, bishops of the same diocese, to be such patrons accordingly, and it appears to us to be expedient that the said right of patronage should be assigned and vested in accordance with such nomination;
