

and in parts of the Continent of America, and it is expedient to put into operation the above-recited provision of the said Act :

Now, therefore, the Lords of Her Majesty's Most Honourable Privy Council do hereby order and direct that from and after the thirtieth of May instant, every vessel coming from or having touched at any Port or Place in Cuba, or coming from or having touched at any Port or Place lying between longitude 35 and 60 degrees west of Greenwich, and between 4 and 40 degrees south latitude, shall come to an anchor at such place or places as may from time to time be appointed by the Commissioners of Her Majesty's Customs, for the purpose of having the state of the health of the crew of such vessel ascertained before such vessel shall be permitted to enter the port whereto she shall be bound, or any other port of the United Kingdom, and shall remain at such place or places until the state of health of such crew shall have been ascertained, pursuant to the said recited provision, and thereafter to be subject to such lawful direction as may be made in that behalf by or under the direction of the said Lords.

And the Right Honourable the Lords Commissioners of Her Majesty's Treasury, and the Lords Commissioners of the Admiralty, are to give

the necessary directions herein as to them may respectively appertain.

THE Lords of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1869, and of every other power enabling them in this behalf, do hereby revoke their Orders described in the Schedule to this Order to the extent in that Schedule mentioned: Provided that nothing herein shall be deemed to invalidate or make unlawful anything done under the said Orders, or either of them, before the date of this revocation, or interfere with the institution or prosecution of any proceeding in respect of any offence committed against, or any penalty incurred under, the said Orders, or either of them.

This Order shall take effect from and immediately after the twenty-ninth day of May, one thousand eight hundred and seventy-one.
