ington, all in the county and diocese aforesaid, which said extremities lie contiguous one to another, and are described in the schedule hereunder writlen, there is collected together a population which is situate at a distance from the several churches of such parishes, chapelry district, and new parish respectively.
" And whereas it appears to us to be expedient that such contiguous portions of the said parislı of West Hackney, of the said parish of Hackney, of the said chapelry district of Dalston, and of the said new parish of Saint Matllias, Stoke Newington, should be formed into a consolidated chapelry for all ecclesiastical purposes, and that the same should be assigned to the said church of Saint Mark, situate at Dalston as aforesaid.
"And whereas the right of presentation and appointment to the said church of Saint Mark, situate at Dalston as aforesaid, is now vested in William Amliurst Tyssen Amluurst, of Dicllington Park, in the county of Norfolk, Esquire, and the said William Amhurst Tyssen Amburst is desirous that such right of presentation and appointment as aforesaid should be transferred to and be vested in and be exercised by the Right Honourable and Right Reverend John, Bishop of the said diocese of London, and by his successors, bishops of the same diocese, for ever.
"Now, therefore, with the consent of the said John, Bishop of the said diocese of Londen, as such Bishop, and also as the alternate patron in right of his see of the vicurage of the said new parish of Saint Matthias, Stoke Newington, with the consent of the Right Honorable William Ewart Gladstone, the First Lord of your Majesty's Treasury, as the other alternate patron on behalf of your Majesty, in right of the Crown, of the same vicarage, with the consent of the said William Amhurst Tyssen Amhurst, as the patron of the rectories both of the said parish of West Hackney, and of the said parish of Hackney, and and also as such patron as aforesaid of the said church of Saint Mark, situate at Dalston as afcresaid, and with the consent of the Reverend Thomas Oliver Goodchild, the rector or incumbent of the rectory of the parish of Hackney aforesaid, and as such rector or incumbent the patron of the perpetual curacy of the said chapelry district of Dalston (in testimony whereof they the said consenting parties have respectively signed and sealed this representation), we, the said Ecclesiastical Commissioners for England, humbly represent that it would, in our opinion be expedient that all those contiguous port ons of the said parish of West Hackney, of the said parish of Hackney, of the said ch:rperly district of Dalston, and of the said new parish of Saint Matthias, Stoke Newington, which are described in the schedule hereunder written, all which portions, together with the boundaries thereof, are delineated and set forth on the map or plan hereunto annexed, should be united and formed into one consolidated chapelry for the said church of Saint Mark, situate at Dalston, as aforesaid, and that the same should be named 'The Consolidated Chapelry of Snint Mark, Dalston,' and tlat the right of presentation and appointment to the church of the same consolidated chapelry should belong to and be excrcised by the said John, Bishop of the said diocese of London, and by his successors, Bishops of the same diocese, for ever.
© We, therefore, humbly pray that your Majesty will be graciously pleased to take the promises into your Royal consideration and to make such Order in respect thereto as to your Majesty, in your Royal wisdom, shall seem meet.

## The SCHEDULE to which the foregoing Representation has reference.

"The Consolidated Chapelry of Saint Mark, Dalston, being : -
"All those several contiguous portions of the parish of West Hackney, of the parish of Hackney, of the chapelry district of Dalston, and of the new parish of Saint Matthias, Stoke Newington, all in the county of Middlesex, and in the diocese of London, which are comprised within and are bounded by an imaginary line commencing upon the boundary which divides the new parish of Saint Jude, Mildmay Park, Islington, in the said county and diocese, from the new parish of Saint Mathịas, Stoke Newington aforesaid, at the point where Back-road is joined by the road called or known as Barrett-grove; and extending thence, first nortli-eastward and then eastward along the middle of the last-named road to the boundary at the junction of the same road with the Stoke Newing-ton-road, which divides the said new parish of Saint Matthias, Stoke Newington, from the parish of West Hackney aforesnid ; and extending thence, southward, along the last-mentioned boundary, thereby following the middle of the said Stoke Newington-road, to the junction of the same road with Wellington-street; and extending thence, eastward, along the middle of the last-named street to its junction with Shacklewell-road ; and extending thence, north-eastward, along the middle of the last-named road, thereby passing along the south-eastern side of Shacklewell-green, to the junction of the same road with the street or road called or known as Amherst-terrace ; and extending thence, eastward. along the middle of the lastnamed street ur road to a point at the eastern end of the same street or road, upon the boundary which divides the said parish of West Hackney from the parish of Hackney aforesaid; and extending thence, first south-eastward and then south-westward, along the last-mentioned boundary, thereby following in part the course of the old Hackney Brook and in part the course of Downs Park-road, to the point where the lastnamed road is intersected by Amherst-road; and extending thence, soutli-eastward, along the middle of the last-named road to its junction with Dalston-lane ; and extending titence, south-westward, along the middle of the last-named lane, to a point at the junction of the same lane with Navarino-road upon the boundary which divides the said parish of Hackney from the chapelry district of Dalston aforesaid; and extending thence, first south-eastyard, then north-eastward, then south-eastward, then south-westward, then gouth-eastward, and then south-westward, flong the last-mentioned boundary, thereby following in part the course of the said Navarino-road to the point where Greenwood-road is joined by Wiltonroad; and extending thence, north-westward, along the middle of the said Greenwood-road to its junction with Graham-road: and extending thence, westward, along the middle of the lastnamed road to a point at the junction of the same road with Dalston-lane aforesaid upon the boundary which divides the said chapelry district of Dalston from the parish of West Hackney aforesaid; and extending thence, first wostward and then southward, along the last-mentioned boundary, thereby following the course of Dalston-lane aforesaid, of Mayfield-street, of Mayfield-road, and of Stone-bridge-road, to the junction of the lastnamed road with Acton-street, where the said last - mentioned boundary is joined by the boundary dividing the said parish of West Hackney from the new parish of All Şainte,
