THE Right Honourable the Lords of the Committee of Privy Council for Trade have received, from the Secretary of State for Foreign Affairs, from Her Majesty's Consul at Lisbon, translations of Quarantine Notices issued by the Portuguese Government, which declare :--

1. The Port of Antwerp infected with Cholera Morbus since the 16th August, and the other Ports of Belgium suspected of the same disease.

2. The Port of Čeara infected with Yellow Fever since the 29th July.

3. The Ports of the Province of Rio Grande de Norte suspected of Yellow Fever.

4. The Port of Monte Video, and all the other Ports of the Oriental Republic, free from Yellow Fever since the 2nd July; and the Port of Buenos Ayres, and the Ports of the Province of Corrientes, as well as those of the Republic of Paraguay, no longer infected with, but suspected of, the same disease.

5. The Ports of the Province of Mozambique free from Cholera Morbus since the 23rd March, with the exception of the Port of Quilimane, which, from the same date, passes out of the category of infected into that of suspected of the same disease.

6. The Port of Königsberg, which by virtue of the notice of the 18th August was considered suspected of Cholera Morbus, to be considered infected with that disease since the 19th of that month.
