THE Right Honourable the Lords of the Committee of Privy Council for Trade have received, from the Secretary of State for Foreign Affairs, a copy of a Despatch from Her Majesty's Consul at Rhodes, reporting that in consequence of the appearance of Cholera at Constantinople, vessels arriving from that port are subjected to ten days' quarantine, in which are reckoned, however, those spent at sea when there is a doctor on board.
