WE, the Ecclesiastical Commissioners for England, in consideration of a benefaction, consisting of two hundred pounds sterling, which has been paid to us in favour of the vicarage of Littlehampton, in the county of Sussex, and in the diocese of Chichester, do hereby, in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, sections five and eleven, grant and appropriate out of our common fund to the said vicarage of Littlehampton, to meet such benefaction, one other capital sum of two hundred pounds sterling, to be applicable towards defraying the cost of providing a parsonage or house of residence for the said vicarage, according to plans and a specification to be approved by us, such capital sum, or the balance thereof unapplied to such purpose, to remain in the meantime in our hands at interest after the rate of three pounds per centum per annum, and such interest to be paid to the Incumbent for the time being of the said vicarage of Littlehampton.

WE, the Ecclesiastical Commissioners for England, in consideration of a benefaction consisting of a portion of the value of one acre two roods and four perches of land, with the dwelling-house and offices thereon, which has been permanently secured to the vicarage of Whitwell, in the Isle of Wight, in the county of Southampton, and in the diocese of Winchester, do hereby, in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, grant to the Incumbent of the said vicarage of Whitwell, and to his successors, to meet such benefaction, one yearly sum or stipend of forty-three pounds six shillings and eight pence, such yearly sum or stipend to be payable out of the common fund under our control, and to be calculated as from the day of the publication of these presents in the London Gazette, and to be receivable in equal half-yearly portions on the first day of May and on the first day of November in each and every year: Provided always, that if at any time lands, tithes, or other hereditaments sufficient, in our opinion, to produce the said yearly sum or stipend, or any part thereof, shall be annexed by us to the said vicarage, in substitution for such yearly sum or stipend, or for such part thereof, our liability for the payment of such yearly sum or stipend, or of
