IVER FAIR.

IN pursuance of the above-mentioned Act, I, the Right Honourable Henry Austin Bruce, one of Her Majesty's Principal Secretaries of State, hereby notify as follows:

1. By Memorial, dated the 5th day of June, 1872, a representation has been duly made to me by the Justices sitting in Petty Sessions for the Division of Stoke, in the county of Bucks, that a Fair has been annually held on the 10th and 11th days of July, in the parish of Iver, in the said division of the said county, and that it would be for the convenience and advantage of the public that such Fair should be abolished.

2. On the 15th day of July, 1872, I shall take the aforesaid representation into consideration, and all persons are to intimate, before that day, any objection they may desire to offer to the abolition of the said Fairs.

Now therefore, I, as the Secretary of State for the Home Department, in exercise of the powers vested in me by "The Fairs Act, 1871," do hereby order that the Fair which has been annually held on the 29th day of July, at Baythorne End, in the parish of Birdbrooke, in the North Hinckford Petty Sessional Division of the county of Essex, shall be abolished as from the date of this order.
