^t ecclesiastical purposes, and the said parochial district is also associated with the said parish of Lanercost for divers lay parochial purposes, and it would be beneficial for the inhabitants to have the said parochial district of Kirkcambeck legally consolidated with the said parish of Lanercost for ecclesiastical purposes.

"That, according to the last census, the population of the said parochial district of Kirkcambeck is seventy-six persons, and the population of the said parish of Lanercost is one thousand one hundred persons.

"That the annual value of the benefice of Lanercost, not reckoning the house of residence as an item of value, is one hundred and seventy-eight pounds or thereabouts.

"That the patronage of the said benefice of Lanercost belongs to the trustees of the Right Honourable the Earl of Carlisle, and the Reverend Isaac Dodgson is the present vicar thereof.

"That it appears to me, that the said parochial district of Kirkcambeck may, under the provisions of the Act of Parliament of the first and second years of Her present Majesty's reign, chapter one hundred and six, and of the second and third years of Her said Majesty's reign, chapter forty-nine, be advantageously united and consolidated with the vicarage and parish church of Lanercost for ecclesiastical purposes.

"That the patron and incumbent of the said parish church of Lanercost are consenting to the scheme hereinafter proposed, and that, conditionally on the event of such scheme being carried into effect, the patrons of the vicarage of Lanercost have undertaken to make a permanent augmentation of the vicarage of the same to the amount of fifteen pounds yearly, and Her Majesty's Ecclesiastical Commissioners have, in like manner, undertaken to provide an additional augmentation thereto of the amount of thirty pounds yearly.

"That, pursuant to the directions contained in the first-mentioned Act of Parliament, I, the said Lord Bishop, have drawn up a scheme, in writing, appended to this representation, describing the mode in which it appears to me that the said union and consolidation may best be effected with justice to all parties, and I do submit the same to your grace to the intent that your grace, if on full consideration and enquiry you shall be satisfied of the said scheme, may certify the same and such consent to Her Majesty in Council.

"SCHEME referred to in the foregoing Representation.

"It is proposed to unite the parochial district of Kirkcambeck with the adjoining parish of Lanercost, and to constitute them one parish and benefice for all ecclesiastical purposes, of which the church of Lanercost shall be the parish church. And that all such and the like fees, payments, ecclesiastical dues, offerings, and emoluments as are usually payable by the parishioners of the parish of Lanercost to the vicar thereof, shall henceforth be payable to him by the inhabitants of Kirkcambeck also ; but that no change be made by this scheme in regard to any glebe lands or tithe rent charged within the said parochial district of Kirkcambeck.

" That the parishioners and inhabitants of Kirkcambeck, shall, in future, be entitled to be seated in the parish church of Lanercost, and to the parochial rights or privileges of baptism, marriage, churchparish church of Lanercost, and shall be liable in common with the other parishioners of Lanercost, to the repair of the said parish church and all such other ecclesiastical dues, duties, offices, and services as are chargeable on the parishioners of the said parish.

And whereas his Grace the Lord Archbishop of York hath, pursuant to the provisions of the said Acts, duly prepared and laid before Her Majesty in Council a certificate and report, in writing, bearing date the third day of June, in the year of our Lord one thousand eight hundred and seventy-two, in the words following (that is to. say):

" To the QUEEN'S Most Excellent Majesty in-Council.

"We, the undersigned, William, by Divine. Providence Lord Archbishop of York, do hereby certify to your Majesty in Council :

"That the Right Reverend Harvey, Lord Bishop of Carlisle, has represented unto us that it appears to him that the ancient parochial district of Kirkcambeck, in the county of Cumberland, and diocese of Carlisle, may be advantageously united and consolidated with the contiguous vicarage and parish of Llanercost, in the same county and diocese for ecclesiastical purposes.

"That the said Lord Bishop has drawn up a representation and scheme, in writing, and has transmitted the same to us for our consideration, describing the mode in which it appears to him that the union may be best effected with. justice to all parties.

"That the patrons and incumbent of the said parish church of Lanercost are consenting to the scheme hereinafter proposed, and that, conditionally on the event of such scheme being carried into effect, the patrons of the vicarage of Lanercost have undertaken to make a permanent augmentation of the vicarage of the same to the amount of fifteen pounds yearly, and your Majesty's Ecclesiastical Commissioners have, in like manner, undertaken to provide an additional augmentation thereto of the amount of thirty pounds yearly.

"The represention of the said Lord Bishop, together with the scheme, in writing, and the consents of the patrons and incumbent before mentioned, are hereunto annexed.

"And we, the said Archbishop, being on full consideration and enquiry satisfied with such. scheme, do hereby certify the same and such consents as aforesaid, to the intent that your Majesty ing, burial and other offices of the church, at the in Council may, in case your Majesty in Council.
