"the incumbent objecting thereto, or by the sur"viving incumbent objecting, if more than one
"shall object thereto, and in such case the last"mentioned provision shall forthwith after such
"avoidance come into operation, and shall be
"binding on all persons whatsoever."

And whereas the Lord Bishop of Bangor hath drawn up, together with a scheme, a representation, in writing, bearing date the fifteenth day of May, in the year of our Lord, one thousand eight hundred and seventy-two, and hath transmitted the same to his Grace the Lord Archbishop of Canterbury, in the words, and figures following (that is to say):

"To the Most Reverend Archibald Campbell, Lord Archbishop of the Province of Canterbury.

"I, James Colquhoun, Lord Bishop of Bangor, do hereby represent to your grace, that there is in the county of Anglesea, and within my diocese of Bangor, the benefice (being a rectory) of Llanddeusant, the parish of which comprises, amongst places, the parochial chapelry of Llanfairynghorwy, the limits and boundaries of which are well known and defined.

"That, according to the last census, the population of the said benefice, exclusive of the said chapelry, is 610, and the population of the said chapelry of Llanfairynghorwy is 270.

"That the said chapelry of Llanfairynghorwy contains a church or chapel, which affords sufficient accommodation for the inhabitants of the said chapelry, and which church or chapel is distant from the parish church of Llanddeusant 5 miles or thereabouts.

"That the said parochial chapelry of Llanfairynghorwy appears to have been from time immemorial treated as a separate and distinct parish for all civil and religious purposes, and is in no way connected as to rates with the said benefice of Llanddeusant.

"That the gross yearly value or income of the said benefice of Llanddeusant, exclusive of the income arising from said chapelry of Llanfairyng-horwy is £473, with 5½ acres of glebe or thereabouts, and the gross yearly value or income arising from the said parochial chapelry of Llanfairyng-horwy is £203, with 46 acres of glebe or thereabouts.

"That there is a house of residence within and belonging to the said parochial chapelry of Llanfairynghorwy, but there is none within or belonging to the said benefice of Llanddeusant.

"That it does not appear that any of the inhabitants or landowners, either of the said parish of Llanddeusant, or of the said parochial chapelry of Llanfairynghorwy, possesses any legal right, by faculty or otherwise, to the exclusive use of any pews or sittings in either of the said churches or chapels.

"That the patronage of, or right of collation to the said rectory of Llanddeusant (which is now vacant) belongs to me, in right of my see of Bangor.

"That it appears to me, that under the provisions of the Acts of Parliament passed in the session holden in the 1st and 2nd years of the reign of Her present Majesty, cap. 106, and of the 2nd and 3rd years of Her Majesty's reign, cap. 49, the said chapelry of Llanfairynghorwy may be advantageously separated from the parish and parish church of Llanddeusant, and be constituted a separate parish for ecclesiastical purposes, and a perpetual chapelry and benefice.

"That, pursuant to the directions of the said firstmentioned Act, I have prepared the following scheme, which, with my consent thereto as patron of the said benefice, I do submit to your grace, to the intent that your grace may, if on full consideration and enquiry you shall be satisfied with such scheme, certify the same, and such consent by your report to Her Majesty in Council:

"The SCHEME above referred to.

"That the said parochial chapelry of Llanfairynghorwy shall be separated from the said parish and parish church of Llanddeusant, and be constituted a separate parish for ecclesiastical purposes, and a perpetual curacy and benefice under the style of the Perpetual Chapelry of Llanfairynghorwy, of which the church or chapel within the said chapelry shall be the parish church.

"That such separate parish and benefice shall be subject to the same ecclesiastical jurisdiction as the said parish of Llanddeusant, and the incumbent of such separate parish and benefice shall have exclusive cure of souls within the limits of

the same.

"That all the tithe, rent charges, or compositions in lieu of tithes, and the house of residence and glebe belonging to the said benefice of Llanddeusant, which arise or accrue, or are payable, or situate within, or in respect of the said chapelry of Llanfairynghorwy, shall henceforth belong and be attached to the said separate parish and benefice of Llanfairynghorwy, and be held, received, and enjoyed by the incumbent thereof, for the time being for ever.

"That all ecclesiastical offices shall be performed in the church of the said separate parish and benefice, and all the fees and payments for such offices and all other ecclesiastical dues, offerings, and emoluments usually payable to the incumbent of a parish or benefice as shall arise within the said separate parish and benefice shall henceforth belong to and be received by the incumbent

thereof

"That the right of patronage of the said separate parish and benefice of Llanfairynghorwy, shall be in me and my successors, Bishops of Bangor, for ever.

"That the inhabitants of the said separate parish and benefice of Llanfairynghorwy shall not be entitled henceforth to any accommodation in any church situate elsewhere than within the limits thereof, nor shall the inhabitants of the said parish of Llanddeusant be entitled henceforth to any accommodation within the said church of Llanfairynghorwy.

"I, the undersigned, James Colquhoun, Lord Bishop of Bangor, the patron of, or person entitled in right of my see to collate to, the said rectory of Llanddeusant (the same rectory being now vacant), do hereby consent to the scheme above proposed and set forth, and to every matter and thing therein contained.

And whereas his Grace the Lord Archbishop of Canterbury hath, pursuant to the provisions of the said Acts, duly prepared and laid before Her Majesty in Council, a certificate, in writing, bearing date the third day of June, in the year of our
