

**A**T the Court at *Windsor*, the 25th day of *June*, 1872.

PRESENT,

The QUEEN's Most Excellent Majesty in Council.

**W**HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the thirty-third and thirty-fourth years of Her Majesty, chapter thirty-nine, and of the Acts therein mentioned, duly prepared and laid before Her Majesty in Council a scheme, bearing date the thirtieth day of May, in the year one thousand eight hundred and seventy-two, in the words following; that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the thirty-third and thirty-fourth years of your Majesty, chapter thirty-nine, and of the Acts therein mentioned, have prepared, and now humbly lay before your Majesty in Council, the following scheme for effecting a transfer of the ownership of the advowson or perpetual right of patronage of and presentation to the church and cure (hereinafter called the said benefice) of *Wye*, in the county of Kent, and in the diocese of Canterbury.

"Whereas the advowson or perpetual right of patronage of and presentation to the said benefice of *Wye*, is vested absolutely in Robert Furley, of Ashford, in the said county of Kent, Gentleman, and his heirs and assigns.

"And whereas the said Robert Furley is desirous that the whole advowson or perpetual right of patronage of and presentation to the said benefice of *Wye*, now vested in him as aforesaid, should be transferred to and be vested in the Archbishop of Canterbury and his successors.

"And whereas the Right Honorable and Most Reverend Archibald Campbell, now Archbishop of Canterbury, is willing to accept such transfer, and in token of such his willingness, and also in token that the same transfer has that consent of his grace, as the bishop of the diocese, which by the Acts in the hereinbefore firstly-mentioned Act recited, or by some or one of them, is made necessary, he, the said Archibald Campbell, has executed this scheme as hereinafter mentioned.

"And whereas it appears to us that the transfer of the patronage of the said benefice of *Wye*, which is hereinbefore mentioned and hereinafter recommended and proposed, will tend to make better provision for the cure of souls in the parish, chapelry, or district in or in respect of which the right of patronage or advowson so recommended and proposed to be transferred as aforesaid arises or exists, that is to say, in the parish, chapelry, or district of *Wye*, because after and by virtue of such transfer, the said benefice of *Wye* will be a benefice in public patronage, and will therefore be capable of receiving an augmentation out of funds administered by us, which augmentation we have conditionally agreed to grant.

"Now, therefore, with the consent of the said Robert Furley (in testimony whereof he has signed and sealed this scheme), and with the consent of the said Archibald Campbell, Archbishop of Canterbury (in testimony of which consent he has signed this scheme, and sealed the same with his episcopal seal), we, the said Ecclesiastical Commissioners for England, humbly recommend and propose, that upon and from the day of the date of the publication in the London Gazette of any Order of your Majesty in Council ratifying this scheme, and without any conveyance or assurance in the law other than such duly gazetted Order, the whole advowson or perpetual right of patronage of and presentation to the said benefice of *Wye*,

now vested in him, the said Robert Furley, and his heirs and assigns as aforesaid, shall be transferred from him, the said Robert Furley, and from his heirs and assigns, to the said Archibald Campbell, Archbishop of Canterbury, and his successors, and shall thereupon and thenceforth become and be absolutely vested in, and shall and may from time to time be exercised by the said Archibald Campbell, Archbishop of Canterbury, and by his successors, Archbishops of Canterbury, for ever.

"And we further recommend and propose, that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Acts, or of either of them, or of any other Act of Parliament.

And whereas the said scheme has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Canterbury.

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the thirty-third and thirty-fourth years of your Majesty, chapter thirty-nine, and of the Acts therein mentioned, have prepared, and now humbly lay before your Majesty in Council, the following scheme for effecting a transfer of the alternate right of patronage of, and presentation to, the church and cure (which said church and cure are hereinafter called 'the said benefice') of Saint Paul, Hoddlesden, in the county of Lancaster, and in the diocese of Manchester.

"Whereas the advowson or perpetual right of patronage of the said benefice of Saint Paul, Hoddlesden, is vested, as to one turn or alternate right of presentation, in William Bayne Ranken, of Hoddlesden Hall, in the said county of Lancaster, and also of number 35, Stanhope-gardens, Queen's-gate, in the county of Middlesex, Esquire, Barrister-at-Law, and his heirs being members of the Church of England, and, as to the other turn or alternate right of presentation, in the patron for the time being of the vicarage and parish church of Blackburn, in the said county of Lancaster, of which said parish of Blackburn the new parish of Saint Paul, Hoddlesden (being the cure of Saint Paul, Hoddlesden aforesaid), did sometime form part.
