

"And whereas the patron of the said vicarage and parish church of Blackburn is the bishop for the time being of the said diocese of Manchester.

"And whereas the said William Bayne Ranken is desirous that the alternate right of patronage of, and presentation to, the said benefice of Saint Paul, Hoddlesden, now vested in him and his heirs as aforesaid, should be transferred to, and be vested in, the owner of the other turn or alternate right of presentation to the same benefice, that is to say, in the bishop for the time being of the said diocese of Manchester, as patron of the said vicarage and parish church of Blackburn aforesaid, so that the whole advowson of the said benefice of Saint Paul, Hoddlesden, may be vested in the said bishop as such patron accordingly.

"And whereas the Right Reverend James, now bishop of the said diocese of Manchester, is willing to accept for himself and his successors (being patrons of the vicarage and parish church of Blackburn as aforesaid), the said proposed transfer, and in token of such, his willingness, and also in token that the same transfer has that consent of the bishop, which by the Acts in the hereinbefore firstly mentioned Act recited, or by some or one of them is made necessary, he, the said James, Bishop of Manchester, has executed this scheme as hereinafter mentioned.

"And whereas it appears to us that the transfer of the alternate right of patronage of, and presentation to, the said benefice of Saint Paul, Hoddlesden, which is hereinbefore mentioned and hereinafter recommended and proposed, will tend to make better provision for the cure of souls in the new parish of Saint Paul, Hoddlesden aforesaid, by reason that the said benefice being thereby placed wholly in patronage, which is treated by us as public, the income of the same benefice will become eligible for augmentation out of funds under our control.

"Now, therefore, with the consent of the said William Bayne Ranken (in testimony whereof he has signed and sealed this scheme), and with the consent of the said James, Bishop of the said diocese of Manchester (in testimony whereof he has signed this scheme, and sealed the same with his episcopal seal), we humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of your Majesty in Council ratifying this scheme, and without any conveyance or assurance in the law other than such duly gazetted Order, the alternate right of patronage of, and presentation to, the said benefice of Saint Paul, Hoddlesden, now vested as aforesaid in him, the said William Bayne Ranken and his heirs, shall be transferred from him, the said William Bayne Ranken and from his heirs, to the patron of the said vicarage and parish church of Blackburn for the time being, that is to say, to the said James, Bishop of the said diocese of Manchester and his successors, and shall thereupon and thenceforth become and be absolutely vested in, and shall and may from time to time be exercised by, him and them accordingly, so that as from the date aforesaid, the whole advowson and every right of patronage of, and presentation to, the said benefice of Saint Paul, Hoddlesden, may be absolutely vested in and exercised by the said James, Bishop of the said diocese of Manchester, and by his successors, bishops of the same diocese (being as aforesaid patrons of the said vicarage and parish church of Blackburn aforesaid, and in right of their being so), for ever.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid, or any

of them, in accordance with the provisions of the said Acts, or of either of them, or of any other Act of Parliament."

And whereas the said scheme has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Manchester.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the seventh and eighth years of Her Majesty, chapter ninety-four, and of the Act of the thirteenth and fourteenth years of Her Majesty, chapter ninety-four, duly prepared and laid before Her Majesty in Council a scheme, bearing date the sixth day of June, in the year one thousand eight hundred and seventy-two, in the words and figures following; that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the seventh and eighth years of your Majesty, chapter ninety-four, and of the Act of the thirteenth and fourteenth years of your Majesty, chapter ninety-four, have prepared and now humbly lay before your Majesty in Council, the following scheme for altering the boundaries of the district of Saint Mark, East-street, Walworth, in the county of Surrey, and in the diocese of London.

"Whereas the said district of Saint Mark, East-street, Walworth, was constituted out of the district parish of Saint Peter, Walworth (within the original limits of the parish of Saint Mary, Newington), in the county and diocese aforesaid, by the authority of an Order of your Majesty in Council, bearing date the twenty-ninth day of November, in the year one thousand eight hundred and seventy, which said Order was published in the London Gazette on the same day.

"And whereas it has been represented to us, and it appears to us to be expedient, that the boundaries of the said district of Saint Mark, East-street, Walworth, should be altered so that they shall include a certain additional part of the district parish of Saint Peter, Walworth aforesaid.

"Now, therefore, with the consent of the Right Honourable and Right Reverend John, Bishop of the said diocese of London (in testimony whereof he has signed and sealed this scheme), we humbly recommend and propose that from and after the day of the date of the publication in the London Gazette, of any Order of your Majesty in Council ratifying this scheme, and without any other assurance in the law other than such gazetted Order, all that part of the said district parish of Saint Peter, Walworth, which is described in the schedule hereunder written, and is delineated and set forth upon the map or plan hereunto annexed, and is thereupon coloured pink, shall be dissevered from such district parish, and shall be annexed to, and
