





ORDER SETTLING THE BOUNDARIES OF A DISTRICT, TO BE STYLED THE DISTRICT OF SHEVINGTON, IN THE COUNTY OF LANCASTER.


WHEREAS a Petition has been presented to the Local Government Board from ratepayers resident within the several townships of Wrightington and Parbold, in the parish of Eccleston, and Shevington, in the parish of Standish, all in the county of Lancaster, praying for the settlement of boundaries of a district, comprising the said three townships, for the purposes of the Local Government Act, 1858 :

And whereas the said petition was signed by one-tenth of the ratepayers resident within the said townships, and inquiry has since been made as to the genuineness of the said petition and the propriety of the proposed boundaries by John Thornhill Harrison, Esquire, the Inspector appointed by the Local Government Board for that purpose:

Now, therefore, we, the said Local Government Board, do hereby in pursuance of the powers vested in us by the Local Government Act, 1858, and the Local Government Board Act, 1871, make Order, that from after the date of this present Order, the boundaries of the district comprising the townships of Wrightington and Parbold, in the parish of Eccleston, and the township of Shevington, in the parish of Standish, shall form and constitute the boundaries of the district to be called the "District of Shevington," for the purposes of the Local Government Act, 1858, and that the parts included in such boundaries shall, for the purposes of such Act, be deemed to be a place having a known and defined boundary, and may adopt the said Act accordingly :—

And we do hereby appoint Thomas Woosnam, of Shevington aforesaid, Yeoman, to be Summoning Officer under the provisions of section 16 of the Local Government Act, 1858, and to take such steps as may be necessary for convening a meeting to decide as to the adoption of the said Act within the said district, and to discharge all other duties which devolve on him as such summoning officer.

THE Civil Service Commissioners hereby give notice, that the following Regulations have been approved by the Lords Commissioners of Her Majesty's Treasury :--

SPECIAL REGULATIONS (supplementary to the General Regulations of 8th April, 1872) respecting Open Competitive Examinations for the situation of Practical Mechanician in the Stamping Office of the Inland Revenue Department.

#### N.B.—These Regulations are liable to alteration,

1. The limits of age for these situations are 24 and 30, and Candidates must be of the prescribed age on the first day of the competitive examination.

2. No Candidate will be eligible who has not passed with credit through the various branches of a Mechanical Engineer's Establishment, and satisfactory evidence on this point will be required.

3. At the compétitive examinations exercises will be set in the following subjects only, viz. :-

1. Arithmetic and Elementary Algebra and Geometry.

2. Mechanical Engineering.

3. Metallurgy (Elementary).

4. The strength and properties of Materials and j Calculation of Strains.

5. Drawing Machinery to scale and by the eye. , Candidates will be required to show a competent knowledge of each of these subjects.

4. No Candidate can be admitted to the competition who has not previously satisfied the Civil Service Commissioners that he possesses the requisite amount of proficiency in the following subjects :-

1. Handwriting;

2. Orthography;

3. Arithmetic (to Vulgar and Decimal Fractions).


