TAXATION OF BILLS OF SOLICITORS AND ATTORNIES.

ORDER issued by the Local Government Board in pursuance of "The Public Health Act, 1872."

To the Clerks of the Peace of the several Counties, Ridings, Divisions, and Places in England and Wales :--

To the several Urban and Rural Sanitary Authoritics in England and Wales constituted by "The Public Health Act, 1872";---

And to all others whom it may concern.

WHEREAS it was enacted by "The Public Health Act, 1872," that, on the application of any Sanitary Authority whose accounts are required by the Sanitary Acts to be audited to the Clerk of the Peace of the county in which the area under the jurisdiction of such Authority is wholly or in part situated, his Deputy should tax any bill due to any Solicitor or Attorney, in respect of legal business performed on behalf of such Authority ; and that the allowance of any sum on such taxation should be primå facie evidence of the reasonableness of the amount, but not of the legality of the charge ; and that the Clerk of the
