The letters and packets described in the schedule hereto, may be transmitted by the post from the countries and places set forth in the first column, to the countries and places set forth in the second column of such schedule, by the routes and and means of conveyance described and set forth in the third column of such schedule, at the rates of postage respectively specified in the same schedule and applicable thereto, and subject to the regulations and conditions hereinafter contained.

2. The postage chargeable under this Warrant upon letters posted in or addressed to the United Kingdom shall be prepaid.

3. If the postage chargeable under this Warrant on a letter posted in or addressed to the United Kingdom is not prepaid, the letter shall be charged (over and above such postage, credit being given for any postage already paid), with an additional rate of postage of sixpence for every such letter if transmitted via France, or with any additional rate of postage of threepence for every half an ounce and fractional part of half an ounce in weight of every such letter if transmitted via Germany and Austria.

4. Registered letters may be transmitted upon payment of such additional charges or rates of postage, or otherwise, as the Postmaster-General from time to time directs or appoints, provided that all rates of postage and additional charges or
