The QUEEN's Most Excellent Majesty in Council.

HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the eighth and ninth years of Her Majesty, chapter seventy; of the Act of the fourteenth and fifteenth years of Her Majesty, chapter ninetyseven; of the Act of the nineteenth and twentieth years of Her Majesty, chapter fifty-five; and of the Act of the thirty-fourth and thirty-fifth years of Her Majesty, chapter eighty-two; duly pre-pared and laid before Her Majesty in Council a representation, bearing date the twelfth day of December, in the year One thousand eight hundred and seventy-two, in the words and figures following; that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the eighth and ninth years of your Majesty, chapter seventy; of the Act of the fourteenth and fifteenth years of your Majesty, chapter ninety-seven; of the Act of the nineteenth and twentieth years of your Majesty, chapter fifty-five; and of the Act of the thirty-fourth and thirty-fifth years of your Majesty, chapter eighty-two, have prepared, and now humbly lay before your Majesty in Council, the following representation as to the assignment of a Consolidated Chapelry to the Consecrated Church called Trinity Church, situate in West Hampstead, in the parish of Hampstead, in the county of Middlesex, and in the diocese of London.

"Whereas at certain extremities of the said parish of Hampstead and of the new parish of Saint Mary Kilburn, in the said county of Middlesex and in the said diocese of London, which said extremities lie contiguous one to another, and are described in the schedule hereunder written, there is collected together a population which is situate at a distance from the several churches of such parish and new parish respectively.

"And whereas it appears to us to be expedient | the course of the same tunnel) to a boundary No. 23947.

Hampstead and of the said new parish of Saint Mary Kilburn should be formed into a Consolidated Chapelry for all ecclesiastical purposes, and that the same should be assigned to the said Church, called Trinity Church, situate in West Hampstead as aforesaid.

"Now, therefore, with the consent of the Right Honorable and Right Reverend John, Bishop of the said diocese of London, with the consent of Sir John Maryon Wilson, of Charlton House, in the county of Kent, Baronet, the patron of the Vicarage of the said parish of Hampstead, and with the consent of the Honourable Arthur Upton, of Number 41, Bryanston square, in the said county of Middlesex, a Lieutenant-General in your Majesty's Army, the patron of the Vicarage of the said new parish of Saint Mary Kilburn (in testimony whereof they the said consenting parties have respectively signed and sealed this representation), we, the said Ecclesiastical Commissioners for England, humbly represent that it would, in our opinion, be expedient that all those contiguous portions of the said parish of Hampstead and of the said new parish of Saint Mary Kilburn, which are described in the schedule hereunder written, all which portions, together with the boundaries thereof, are delineated and set forth on the map or plan hereunto annexed, should be united and formed into one Consolidated Chapelry for the said Church, called Trinity Church, situate in West Hampstead as aforesaid, and that the same should be named 'The Consolidated Chapelry of the Trinity, West Hampstead.'

"We, therefore, humbly pray that your Majesty will be graciously pleased to take the premises into your Royal consideration, and to make such order in respect thereto as your Majesty in your Royal wisdom shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The Consolidated Chapelry of The Trinity," West Hampstead, being:-

"All that portion of the parish of Hampstead, in the county of Middlesex, and in the diocese of London, and also all that contiguous portion of the new parish of Saint Mary, Kilburn, in the same county and diocese, which are comprised within and are bounded by an imaginary line commencing upon the boundary which divides the district chapelry of All Saints, Child's-hill, Hendon, in the said county and diocese, from the parish of Hampstead aforesaid, at a point near Child's-hill in the middle of the Finchley-road, and extending thence south-eastward, for a distance of one mile or thereabouts, along the middle of the said road (thereby following in part the boundary which divides the said parish of Hampstead from the new parish of St. Mary, Kilburn, aforesaid, and crossing the line of the Hampstead Junction Railway) to a point near the Finchleyroad Station on the line of the Midland Railway, and opposite to a boundary stone inscribed 'W. H. T. C. U., 1872, No. 1,' and placed on the eastern side of the same road, immedia ely over the middle of the said line of railway, and extending thence eastward to such boundary stone, and continuing thence still eastward for a distance of three chains or thereabouts to and along the middle of the same line of railway to the western entrance of the Belsize Tunnel, and continuing thence still eastward and in a direct line, for a distance of twenty-nine chains or thereabouts (thereby following on the surface of the ground
