stone inscribed 'W. H. T. C. C., 1872, No. 2,' and placed immediately over the said tunnel by the side of the public footpath which leads from Greenhill-road into Belsize-lane, and extending thence south-eastward along the middle of the said footpath, for a distance of five chains or thereabouts, to the boundary in the middle of the said Belsize-lane which divides the said parish of Hampstead from the new parish of Saint Peter, Belsize-park, in the county and diocese aforesaid, and extending thence south-westward, for a distance of thirty-one chains or thereabouts, along the last-described boundary, thereby following the course of Belsize-lane aforesaid, to the point near to the junction of the same lane with the road called or known as College-crescent where the said last-described boundary is joined by the boundary which divides the said parish of Hampstead from the new parish of Saint Paul, Hampstead, in the county and diocese aforesaid, and extending thence first westward and then south-westward along the last-described boundary (thereby passing a little to the north of the northern side of the said College-crescent, and also passing to the north-west of the house called or known as 'The North Star') to the point in the middle of the Finchley-road aforesaid, about five chains to the south of Trinity Church, where the last-mentioned boundary is joined by the boundary which divides the said new parish of Saint Mary, Kilburn, from the new parish of All Souls, Hampstead, in the county and diocese aforesaid, and continuing thence still south-westward, for a distance of twenty-two chains or thereabouts, along the last-described boundary (thereby passing along the rear of the houses and gardens situate on the north-western side of Fairfax-road, sometime called Victoria-road) to the point where Northendroad is joined by the footpath leading to Gipsy-lane and extending thence north-westward for a distance of half a mile or thereabouts along the middle of the said footpath to its junction with Gipsy-lane aforesaid, and extending thence westward for a distance of eight chains or thereabouts along the middle of the last-named lane to its junction with West End Lane, otherwise called or known as Kilburn Lane, and extending thence northward for a distance of six chains or thereabouts along the middle of the last-named lane to a point in the centre of the bridge which carries the same lane over the line of the Hampstead Junction Railway aforesaid, upon the boundary which divides the said new parish of Saint Mary, Kilburn, from the parish of Hampstead aforesaid, and extending thence south-westward for a distance of about half a mile along the last-mentioned boundary (thereby following the middle of the last-named line of railway) to the point in the centre of the bridge which carries the same line of railway over the Edgware Road where the said last-mentioned boundary is joined by the boundary which divides the said parish of Hampstead from the district chapelry of Christ Church, Brondesbury, in the county and diocese aforesaid, and extending thence north-westward along the last described boundary and along the boundary which divides the said parish of Hampstead from the parish of Willesden, in the county and diocese aforesaid (both which last-mentioned boundaries follow the course of the Edgware Road aforesaid), to the point near Cricklewood, where the boundary which divides the said parish of Hampstead from the parish of Willesden, as last described, is joined by the boundary which divides the said parish of Hampstead from the district chapelry of All Saints, Child'shill, Hendon, aforesaid, and extending thence generally north-eastward along the last-described of the said parish of Radcliffe (in testimony

loundary (thereby crossing the line of the Midland. Railway aforesaid) to the first-described point near Child's-hill in the middle of the Finchleyroad as aforesaid, at which point the said imaginary line commenced."

And whereas the said representation has been approved by Her Majesty in Council; now, therefore, her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this order shall have been duly published in the London Gazette, pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this order-be forthwith registered by the Registrar of the said diocese of London,

HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the eighth and ninth years of Her Majesty, chapter seventy; of the Act of the nineteenth and twentieth years of Her Majesty, chapter fifty-five; and of the Act of the thirty-fourth and thirty-fifth years of Her Majesty, chapter eighty-two; duly prepared and laid before Her Majesty in Council a representation, bearing date the nineteenth day of December, in the year one thousand eight hundred and seventy-two, in the words following; that is to say:-

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the eighth and ninth years of your Majesty, chapter seventy; of the Act of the nineteenth and twentieth years of your Majesty, chapter fifty-five: and of the Act of the thirty-fourth and thirty-fifth years of your Majesty, chapter eighty-two; have prepared, and now humbly lay before your Majesty in Council, the following representation as to the assignment of a consolidated chapelry to the consecrated church of Saint Peter, situate at Redvales, within the limits of the parish of Bury, in the county of Lancaster, and in the diocese of Manchester.

"Whereas at certain extremities of the said parish of Bury, and of the parish of Radcliffe, in the said county of Lancaster, and in the said diocese of Manchester, which said extremities lie contiguous one to another, and are described in the schedule hereunder written, there is collected together a population which is situate at a distance from the several churches of such respective parishes.

"And whereas it appears to us to be expedient that such contiguous portions of the said parish of Bury and of the said parish of Radcliffe, should be formed into a consolidated chapelry for all ecclesiastical purposes, and that the same should be assigned to the said church of Saint Peter, situate at Redvales as aforesaid.

"Now, therefore, with the consent of the Right Reverend James, Bishop of the said diocese of Manchester, and with the consent of the Right Honourable Edward Henry Earl of Derby, the-Patron of the rectory of the said parish of Bury, and with the consent of the Right Honourable Thomas, Earl of Wilton, the patron of the rectory
