

whereof they, the said consenting parties, have respectively signed and sealed this representation) we, the said Ecclesiastical Commissioners for England, humbly represent that it would in our opinion be expedient that all those contiguous portions of the said parish of Bury and of the said parish of Radcliffe, which are described in the schedule hereunder written, all which portions together with the boundaries thereof, are delineated and set forth on the map or plan hereunto annexed, should be united and formed into one consolidated chapelry for the said church of Saint Peter, situate at Redvales, within the limits of the said parish of Bury, and that the same should be named 'The Consolidated Chapelry of Saint Peter, Bury.'

"We therefore humbly pray that your Majesty will be graciously pleased to take the premises into your Royal consideration, and to make such order in respect thereto as to your Majesty, in your Royal wisdom, shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The Consolidated Chapelry of Saint Peter, Bury, being:

"All that portion of the parish of Bury, in the county of Lancaster, and in the diocese of Manchester, and also all those two contiguous portions of the parish of Radcliffe, in the same county and diocese, wherein the present incumbents of such parishes now respectively possess the exclusive cure of souls, which said portions of such parishes are comprised within and are bounded by an imaginary line commencing at the junction of the river Irwell with the river Roch, where the boundary dividing the said parish of Radcliffe from the parish of Bury aforesaid meets the boundary dividing the last-named parish from the district parish of Stand, in the county and diocese aforesaid, and extending thence generally north-eastward along the last-described boundary, and along the boundary which divides the said parish of Bury from the parish of Prestwich, and from the parish of Middleton, and from the particular district of Saint James, Heywood, all in the county and diocese aforesaid (thereby following in part the course of the river Roch aforesaid), to the point in the centre of the viaduct which carries the line of the Lancashire and Yorkshire Railway over the last-named river, where the boundary dividing the said parish of Bury from the particular district of Saint James, Heywood, aforesaid, meets the boundary which divides the said parish of Bury from the consolidated chapelry of Saint Thomas, Bury, in the county and diocese aforesaid, and extending thence westward along the last-described boundary, and along the boundary dividing the said parish of Bury from the new parish of the Most Holy Trinity, Bury, in the county and diocese aforesaid (thereby following the middle of the line of the Lancashire and Yorkshire Railway aforesaid), to the point in the centre of the bridge which carries Knowsley-street over the said line of railway, where the last-described boundary diverges to the north from the same line of railway, and extending thence from the said boundary, but in a direction still westward for a distance of ten chains or thereabouts along the middle of the said line of railway to the point where it is crossed by the line of the East Lancashire Railway, and extending thence south-westward for a distance of seventy-six chains or thereabouts along the middle of the last-named line of railway (thereby crossing the boundary which divides the said parish of Bury from the parish of Radcliffe aforesaid) to a point near Hutchinson's Weir, in the centre of the viaduct

which carries the same line of railway over the River Irwell aforesaid, and extending thence for a distance of sixty-eight chains or thereabouts first eastward then southward, and then again eastward along the middle of the last-named river to a point in the centre of Hardy's Gate-bridge upon the boundary which divides the said parish of Radcliffe from the parish of Bury aforesaid and extending thence for a distance of thirty-eight chains or thereabouts, first south-westward, then southward, then eastward, and then again southward along the last-described boundary (thereby leaving the said River Irwell and again returning to it, and also crossing and recrossing the Radcliffe Trust Road, otherwise called or known as Dumer's Lane) to a point in the centre of the said river, and extending thence from the last-described boundary, first westward and then south-eastward, along the middle of the same river for a distance of thirty-five chains or thereabouts to the point where it is again crossed by the boundary which divides the said parish of Radcliffe from the parish of Bury aforesaid, and extending thence in a direction generally southward for a distance of twenty-two chains or thereabouts along the same boundary (thereby leaving the said River Irwell and again returning to it) to the first-described point at the junction of the said River Irwell with the River Roch as aforesaid, where the said last-described boundary is joined by the boundary which divides the said parish of Bury from the district parish of Stand as aforesaid at which point the said imaginary line commenced."

And whereas the said representation has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of her said Council, is pleased hereby so ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the registrar of the said diocese of Manchester.
