Commissioners, further represent, that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings, and burials should be solemnized or performed at such church, and that the fees to be received in respect of the publication of such banns and of the solemnization or performance of the said offices should be paid and belong to the minister of the same church for the time being: Provided always, that nothing herein contained shall be construed as expressing any intention on the part of us, the said Commissioners, to concur in or approve the taking of any fee for the performance of the said office of baptism, or for the registration thereof.

"We, therefore, humbly pray that your Majesty will be graciously pleased to take the premises into your Royal consideration, and to make such Order with respect thereto as to your Majesty, in your Royal wisdom, shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of Saint James, Westgate, being:

"All that part of the parish of Saint John the Baptist, Thanet, otherwise called Margate, in the county of Kent, and in the diocese of Canterbury, wherein the present Incumbent of such parish now possesses the exclusive cure of souls, which is bounded on the north by the sea, on the west by a detached portion of the parish of Minster, in the said county and diocese, on the south partly by the parish of Birchington with Acol, in the same county and diocese, and on all other sides, that is to say, on the remaining part of the south and on the east by an imaginary line commencing at a point in the middle of the Acol-road, where it is crossed by the boundary which divides the said parish of Birchington with Acol from the parish of Saint John the Baptist, Thanet, otherwise called Margate, aforesaid, and extending thence eastward along the middle of the said Acol-road for a distance of one mile or thereabouts to a point at 'Twenties,' where the same road is joined by the foothpath which leads from 'Twenties' aforesaid past 'Crow-hill Cottage' towards Garlinge, and extending thence northwestward along the middle of the said footpath for a distance of half a mile or thereabouts to its junction at or near to 'Crow-hill Cottage' aforesaid with the road leading from Garlinge to Hartsdown, and with the footpath which leads from the last-described road into the turnpike-road leading from Canterbury to Margate, and extending thence, that is, from the last-described point of junction north-eastward for a distance of twentyseven chains or thereabouts across the road leading from Garlinge to Hartsdown as aforesaid, and along the middle of the last-described footpath to the point a little to the south-west of the bridge which carries the turnpike-road leading from Canterbury to Margate as aforesaid over the line of the London, Chatham, and Dover Railway where the same footpath joins the said turnpikeroad, and continuing thence still north-eastward along the middle of the same turnpike-road for a distance of thirteen chains or thereabouts (thereby crossing the line of the London, Chatham, and Dover Railway as aforesaid) to the point where the said turnpike-road is joined by Westgate-road, and extending thence westward for a distance of two chains or thereabouts along the middle of the last-named road to its junction with the road which leads past the western side of the row of houses called or known as Westbrook-

terrace' to the cliff, and extending thence northward, for a distance of ten chains or thereabouts, along the middle of the last-described road to its northern end on the cliff aforesaid, and continuing thence still northward and in a direct line to the northern boundary of the said parish of Saint John the Baptist, Thanet, otherwise called Margate, upon the sea shore."

And whereas the said representation has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Canterbury.

HEREAS the Ecclesiastical Commissioners for England have, in pursuance of an Act of the sixth and seventh years of Her Majesty, chapter thirty-seven, sections six and eight, duly prepared and laid before Her Majesty in Council a scheme, bearing date the ninth day of January, in the year one thousand eight hundred and seventy-three, in the words following, that is to say:

to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of an Act of the sixth and seventh years of your Majesty, chapter thirty-seven, sections six and eight, have prepared and now humbly lay before your Majesty in Council the following scheme for authorizing the sale and disposal of certain property formerly belonging to the dean and chapter of the cathedral church

of Durham, and now vested in us.

"Whereas, under "The Ecclesiastical Commission Act, 1868," and by virtue of an Order of your Majesty in Council, made under the provisions of the same Act bearing date the twenty-seventh day of November, one thousand eight hundred and seventy-two, and duly published in the London Gazette on the tenth day of December in the same year, all the property which then belonged to the said dean and chapter of Durham (excepting certain portions thereof in such Order particularly excepted, and excepting also any ecclesiastical, educational, or other like patronage) was transferred to and became absolutely vested in us for the purposes and subject to the provisions applicable to other hereditaments vested in us.

"And whereas the property aforesaid consists to a considerable extent of reversions expectant upon grants and leases for lives and years, and produces during the subsistence of such grants and leases only small annual revenues, and on that account, and in some instances on account of its character or situation, is unsuitable or inconvenient to be assigned as an endowment for the said dean and chapter, or to be held or applied for the other purposes for which estates vested in us are applicable under the Acts by which our proceedings are governed.

"And whereas by an Act of the twenty-third and twenty-fourth years of your Majesty, chapter
