THE Board of Trade have received from the Secretary of State for Foreign Affairs a translation of a Decree (of which the following is a copy) by the Emperor of Brazil respecting the coasting trade of that country:—

Making use of the authority conferred on the Government in Article 23 of the Law 1177 of the 9th September, 1866, I hereby prolong until the end of December, 1873, if previously no other provision be adopted by the General Assembly, the dispositions of Decree No. 3631 of the 27th March, 1866, which permit foreign ships to engage in the coasting trade between the ports of the Empire where Custom-houses are established.

Viscount Rio Branco, &c., &c., is charged with the execution of this Decree.
