his ability, and if any such conductor fails to enforce the same as aforesaid he shall be deemed to have committed a breach of these bye-laws and regulations.

23. Any person offending against or committing a breach of any of these bye-laws or regulations shall be liable to a penalty not exceeding

40s.

24. The expression "conductor" shall include any officer or servant in the employment of the Company, and having charge of a carriage.

25. There shall be placed and kept placed in a conspicuous position inside of each carriage in use a printed copy of these bye-laws and regulations.

26. These bye-laws shall come into force on

the 25th day of March, 1873.
