MONKS ELEIGH FAIR.

WHEREAS a representation has been duly made to me, as Secretary of State for the Home Department, by the Justices acting in the Melford Petty Sessional Division of the hundred of Babergh, in the county of Suffolk, that a Fair has been annually held on Whit Monday and Whit Tuesday, in the parish of Monks Eleigh, in the said division of the said county, and that it would be for the convenience and advantage of the public that the said Fair should be abolished:

And whereas notice of the said representation, and of the time when I should take the same into

consideration, has been duly published in pursuance of "The Fairs Act, 1871:"

And whereas, on such representation and consideration, it appears to me that it would be for the convenience and advantage of the public that the said Fair should be abolished:

And whereas it appears that there is no lord or owner of the said Fair and the tolls thereof:

Now, therefore, I, as the Secretary of State for the Home Department, in exercise of the powers vested in me by "The Fairs Act, 1871," do hereby order that the Fair which has been annually held on Whit Monday and Whit Tuesday, in the parish of Monks Eleigh, in the Melford Petty Sessional Division of the hundred of Babergh, in the county of Suffolk, shall be abolished as from the date of this order.
