**METROPOLIS LOCAL MANAGEMENT ACTS AMENDMENT ACT, 1862.**

25 and 26 Vict., cap. 102, sect. 41.

*Metropolitan Board of Works.*

AT a Meeting of the Board, at their Office, Spring-gardens, this fourteenth day of March, one thousand eight hundred and seventy-three, amongst the Orders is as follows:—

Whereas, by the Metropolis Management Amendment Act, 1862, it is enacted that when at any time, upon any account taken of the population by the authority of Parliament, any of the parishes within the metropolis not then divided into wards, for the purpose of electing vestrymen, should be found to contain more than two thousand
