(1.) Discovery of a Shoal near Cartier Islet.

THE Colonial Government of Queensland has given notice, that the master of the barque "Woodbine," when about 7 or 8 miles northwestward of the sand islet discovered by the ship Cartier," found shoal water, and got one cast of The shoal appeared to extend to the 10 fathoms. north and north-westward as far as could be seen from the mast-head, with apparently shoal water in many places.
