THE Board of Trade have received through the Secretary of State for Foreign Affairs, a copy of a Despatch from Her Majesty's Minister at Madrid, forwarding an extract from the Madrid Gazette, which states that Northern Brabant and Southern Holland since the 25th October, and the Bay of Naples since the 20th October, have been declared foul of cholera. Also, that the following places have been declared clean: Hamburg and Venice, since the 24th November; Genoa, since the 29th November; Corfu and Catacolo, since the 6th November; Bayonne, Bordeaux, Marseilles, St. Jean de Luz, and Socoa (no date mentioned); the Turkish provinces on the Danube, Niausta, and Salonica, since the 21st November, and Havre, since the 1st December.

THE Board of Trade have received through the Secretary of State for Foreign Affairs a copy of a Despatch from Her Majesty's Minister at Rome, stating that the Italian Ministry of the Interior has issued a Decree, dated the 28th November, by which vessels from Genoa, in view of the cessasion of cholera in that city, are admitted to free pratique throughout the kingdom, with the exception of the ports of Sicily and Sardinia.

THE REGULATION OF RAILWAYS ACT, 1873.

REGULATION.

WHEREAS Section 10 of the Regulation of Railways Act, 1873, transfers to the Railway Commissioners certain powers and duries of the Board of Trade under the Railway Clauses Act, 1863, and amongst others, the power of approving the form of notice to be given to the public by Railway Companies of their intention to enter into agreements amongst themselves under Part III. of the last-mentioned Act.

The form so approved by the Commissioners is as follows:

The Railway Company,

and the ... Railway Company.

Notice is hereby given, pursuant to the provisions of the Railways Clauses Act, 1803, and
