THE Board of Trade have received through the Secretary of State for Foreign Affairs a Despatch from Her Majesty's Consul at Monte Video, stating that on account of more cases of cholera being reported in Buenos Ayres, the quarantine with that and other Argentine ports has been increased to twenty days at Monte Video, which has the effect of shutting off all communication except by the Ocean Mail Steamers.

THE Board of Trade have received through the Secretary of State for Foreign Affairs a Despatch from Her Majesty's Consul at Lisbon, stating that by Government Notice at that place, the Island of Mauritius has been declared free from yellow fever, the port of Riga free from cholera morbus since the 28th November last, and the port of Buenos Ayres "infected" with cholera morbus since the 10th December last.

THE Board of Trade have received through the Secretary of State for Foreign Affairs a Despatch from Her Majesty's Minister at Madrid, stating that the Spanish Board of Health had published three Notices, dated the 27th ultimo, by which—

Firstly. Arrivals in Spanish ports from the United States of America with clean bills of health and Spanish visa are admitted to free pratique if in a good hygienic state and with no suspicious case on board, provided that in the opinion of the Local Director and Board of Health there is no danger to public health.

Secondly. A quarantine is established on account of yellow fever on all arrivals from Pernambuco and neighbouring places (Brazil) which have put to sea since the 20th December last.

Thirdly. On account of cases of cholera reported from Argentine ports, all vessels which have sailed from thence since the 1st December last, and which arrive in Spanish ports in a good hygienic state, with clean bills of health and with no suspicious case on board are placed under three days' observation.
