To the Guardians of the Poor of the Hunslet Union, in the West Riding of the county of York, being the Sanitary Authority for the Rural Sanitary District of that Union ;--

To the Overseers of the several Townships comprised in the said Union ;---

And to all others whom it may concern.

WHEREAS by Section 23 of the Public Health Act, 1872, the Local Government Board are empowered, on the application of the Authority of any Rural Sanitary District, by Order, to be published in the London Gazette, or in such other manner as they may direct, to invest such Authority with all or any of the powers, rights, duties, capacities, liabilities, and obligations of an Urban Sanitary Authority;

And whereas the Guardians of the Poor of the Hunslet Union, in the West Riding of the county of York, being the Sanitary Anthority for the Rural Sanitary District of that Union, have applied to the Local Government Board to issue an Order investing them, as such Sanitary Authority, with all the powers, rights, duties, capacities, liabilities, and obligations of an Urban Sanitary Authority, with reference to making bylaws in respect to the various matters mentioned in Subsection 4 of Section 32, and in Sub-section 4 of Section 34 of the Local Government Act, 1858; and also with reference to slaughter-houses, under or by virtue of Section 45 of that Act :

Now, therefore, We, the Local Government Board, having duly considered the said application, and acting under the authority of the several statutes in that behalf, do hereby invest the Guardians of the Poor of the said Hunslet Union, as such. Sanitary Authority within such district as aforesaid, from and after the 5th day of February next, with all the powers, rights, duties, capacities, liabilities, and obligations of an Urban Sanitary Authority, with reference to making bylaws in respect to the various matters mentioned in Sub-section 4 of Section 32, and in Sub-section 4 of Section 34 of the Local Government Act, 1858, and also with reference to slaughter-houses, under or by virtue of Section 45 of that Act.

And We do hereby direct the said Guardiansto cause this our Order to be published once in some newspaper circulated within their District, before the expiration of one calendar month from the date hereof.
