**THE FAIRS ACT, 1871.****OXTED FAIR.**

IN pursuance of the above-mentioned Act,  
I, the Right Honourable Richard Assheton Cross,  
one of Her Majesty's Principal Secretaries of  
State, hereby notify as follows:

1. By Memorial, dated 16th day of February,  
1874, a representation has been duly made to me  
by the Magistrates of the Petty Sessional District  
of Godstone, in the county of Surrey, that a Fair  
has been annually held in the street of the village  
of Oxted, within the said District, on the 1st day  
of May, and that it would be for the convenience  
and advantage of the public that such Fair should  
be abolished:

2. On the 2nd day of April, 1874, I shall  
take the aforesaid representation into considera-  
tion, and all persons are to intimate, before that  
day, any objection they may desire to offer to  
the abolition of the said Fair.
