

WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, do hereby, subject as hereinafter mentioned, grant to the Incumbent for the time being of the benefice of Saint Clement, Kensington, in the county of Middlesex, and in the diocese of London, one yearly sum or stipend of one hundred and twenty pounds, such yearly sum or stipend to be payable out of the common fund under our control, and to be calculated as from the seventh day of September, in the year one thousand eight hundred and seventy-three, and to be receivable in four equal portions, on the first day of February, the first day of May, the first day of August, and the first day of November in each and every year: Provided always, that the annual sum or stipend so granted by us to the Incumbent of the said benefice shall be paid only upon the production to us, on or after each of the said lastly-mentioned days in each and every year, of a certificate under the hand of the Bishop of the said diocese of London, that an Assistant-Curate, duly licensed by such Bishop, has been employed within the parish of Saint Clement, Kensington aforesaid, during the quarter of the year then ended, and is in receipt of a salary after a rate of not less than one hundred and twenty pounds per annum: Provided also, that such yearly sum or stipend shall continue payable as aforesaid so long only as may to us appear to be expedient under the circumstances from time to time affecting the said parish and benefice of Saint Clement, Kensington.

WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, sections five and eleven, do hereby grant to the Incumbent of the vicarage of Saint Paul, Paddington, in the county of Middlesex, and in the diocese of London, and to his successors, Incumbents of the same vicarage, one yearly sum or stipend of two hundred pounds, such yearly sum or stipend to be payable out of the common fund under our control, and to be calculated as from the thirtieth day of January, in the year one thousand eight hundred and seventy-four, and to be receivable in equal half-yearly portions, on the first day of May and on the first day of November in each and every year. And we do also hereby grant and appropriate out of our said common fund to the said vicarage of Saint Paul, Paddington, one capital sum of one thousand five hundred pounds sterling, to be applicable towards defraying the cost of providing a parsonage or house of residence for the said vicarage, according to plans and a specification approved or to be approved by us, such capital sum, or the balance thereof unapplied to such purpose, to remain in the meantime in our hands at interest after the rate of three pounds per centum per annum, and such interest to be paid to the Incumbent for the time being of the said vicarage of Saint Paul, Paddington: Provided always, that if at any time lands, tithes, or other hereditaments sufficient, in our opinion, to produce the said yearly sum or stipend of two hundred pounds, or any part thereof, shall be annexed by us to the said vicarage, in substitution for such yearly sum or stipend, or for

such part thereof, our liability for the payment of such yearly sum or stipend, or of such part thereof, as the case may be, shall thereupon and thereafter cease and determine.

WE, the Ecclesiastical Commissioners for England, in consideration of a benefaction of four hundred and sixty pounds sterling, which has been paid to us in favour of the consolidated chapelry or benefice of Saint John the Evangelist, Glamford Bridge, in the county and diocese of Lincoln, and in respect of a portion (amounting to three hundred and sixty pounds) of which benefaction we have agreed to pay to the Incumbent of the said consolidated chapelry or benefice, and to his successors, a yearly sum of twelve pounds, do hereby, in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, sections five and eleven, grant to the Incumbent of the said consolidated chapelry or benefice of Saint John the Evangelist, Glamford Bridge, and to his successors, Incumbents of the same consolidated chapelry or benefice, to meet the aforesaid benefaction, one other yearly sum or stipend of twelve pounds, such yearly sum or stipend to be payable out of the common fund under our control, and to be calculated as from the day of the publication of these presents in the London Gazette, and to be receivable in equal half-yearly portions, on the first day of May and on the first day of November in each and every year: And we do also in further consideration of the aforesaid benefaction, hereby grant and appropriate out of our said common fund to the said consolidated chapelry or benefice of Saint John the Evangelist, Glamford Bridge, one capital sum of one hundred pounds sterling, to be applicable towards defraying the cost of providing a parsonage or house of residence for the said consolidated chapelry or benefice, according to the plans and specification approved by us, such capital sum, or the balance thereof unapplied to such purpose, to remain in the meantime in our hands at interest after the rate of three pounds per centum per annum, and such interest to be paid to the Incumbent for the time being of the said consolidated chapelry or benefice: Provided always, that if at any time lands, tithes, or other hereditaments sufficient in our opinion to produce the said yearly sum or stipend of twelve pounds, to be payable out of our common fund as aforesaid, or any part thereof, shall be annexed by us to the said consolidated chapelry or benefice, in substitution for such yearly sum or stipend, or for such part thereof, our liability for the payment of such yearly sum or stipend, or of such part thereof, as the case may be, shall thereupon and thereafter cease and determine.
